APPLICATION

On August 30, 2018, Kerr-McGee Oil & Gas Onshore LP (Operator No. 47120) ("Kerr-McGee" or "Applicant"), filed a verified application pursuant to §34-60-116, C.R.S. for an order to:

- 1) Pool all interests in three approximate 720-acre designated horizontal wellbore spacing units, established for the Application Lands, for the development and operation of the Niobrara and Codell Formations; and
- 2) Subject any nonconsenting interests to the cost recovery provisions of §34-60-116(7), C.R.S., effective as of the earlier of the date of the Application, or the date that any of the costs specified in §34-60-116(7)(b), C.R.S., were first incurred for the drilling of the Robin 9-13HZ Well (API No. 05-123-45251) Niobrara Formation – WSU No. 1, the Robin 9-14HZ Well (API No. 05-123-45248) Codell Formation – WSU No. 2, and the Robin 9-15HZ Well (API No. 05-123-45247) Codell Formation – WSU No. 3 ("Wells").
