APPLICATION

On August 30, 2018, Extraction Oil & Gas, Inc. (Operator No. 10459) ("Extraction" or "Applicant") filed a verified application pursuant to §34-60-116, C.R.S., for an order to:

- 1) Pool all interests in an approximate 640-acre drilling and spacing unit covering the Application Lands for the development and operation of the Niobrara and Codell Formations.
- 2) Subject any nonconsenting interests to the cost recovery provisions of §34-60-116(7), C.R.S., effective as of the earlier of the date of the Application, or the date that any of the costs specified in §34-60-116(7)(b), C.R.S., were first incurred for the drilling of the: Interchange B N35-20-4N Well (API No. 05-014-20774); Interchange B N35-20-5C Well (API No. 05-014-20772); Interchange B N35-20-6N Well (API No. 05-014-20777); Interchange B N35-20-7N Well (API No. 05-014-20775); Interchange B N35-20-8C Well (API No. 05-014-20776); and Interchange B N35-20-9N Well (API No. 05-014-20773).

- On October 24, 2016, the Commission entered Order No. 407-1829, which among other things established an approximate 640-acre drilling and spacing unit covering the E½ of Sections 3 and 10, Township 1 South, Range 68 West, 6<sup>th</sup> P.M. for the production of oil, gas, and associated hydrocarbons from the Niobrara and Codell Formations.
- On October 31, 2017, the Commission entered Order No. 407-2223, which vacated Order No. 407-1829 and established an approximate 640-acre drilling and spacing unit covering the Application Lands for the production of oil, gas, and associated hydrocarbons from the Niobrara and Codell Formations and approved one horizontal well within the unit.

- On October 31, 2017, the Commission entered Order No. 407-2222, which among other things, approved up to ten horizontal wells within the Application Lands for the production of oil, gas, and associated hydrocarbons from the Niobrara and Codell Formations.

One electronic (cogcc.hearings\_unit@state.co.us), one original and two copies shall be filed with the Commission. **Anyone who files a protest or intervention must be able to participate in a prehearing conference during the week of October 15, 2018, if a prehearing conference is requested by the Applicant, or any person who has filed a protest or intervention.** Pursuant to Rule 511., if the matter is uncontested, it may be approved without a hearing.
