APPLICATION

On August 30, 2018, CCRP Operating, Inc. (Operator No. 10665) ("CCRP" or "Applicant"), filed a verified application pursuant to Commission Rule 503.b.(10) and the Colorado Oil and Gas Conservation Act for an order to:

1. Deny Upland Exploration, LLC's Application for Permit to Drill, Form 2, ("APDs") for the Little Lady 21-1NH Well (Document No. 401720337), the Little Lady 21-2CH Well (Document No. 401720612), the Little Lady 21-3NH Well (Document No. 401720665), the Little Lady 21-4CH Well (Document No. 401720686), the Little Lady 21-5NH Well (Document No. 401720710), the Little Lady 21-6CH Well (Document No. 401720744), and the Little Lady 21-7NH Well (Document No. 401720963) (collectively, the "Little Lady Wells" or "Little Lady APDs") located in Section 21, Township 11 North, Range 64 West, 6th P.M. ("Wells") filed with the COGCC for the Application Lands.

2. Applicant also requests any such other findings and orders as the Commission may deem proper or advisable.

APPLICABLE ORDERS AND RULES

- Colorado Oil and Gas Conservation Commission Rule 503.b.(10) provides that for purposes of seeking relief or a ruling from the Commission on any other matter not

described in Rule 503.b.(1)-(9), only persons who can demonstrate that they are directly and adversely affected or aggrieved by the conduct of oil and gas operations or an order of the Commission and that their interest is entitled to legal protection under the Act may be an applicant.

- On May 31, 2018, Highpoint Operating Corporation (Operator No. 10071) (“Highpoint”) filed an application in Docket No. 180700574 for an order from the Commission to establish an approximate 1,280-acre drilling and spacing unit for the above-referenced Application Lands and allow up to 16 new horizontal wells in the unit, for the production of oil, gas, and associated hydrocarbons from the Niobrara, Fort Hays, Codell, and Carlile Formations in the unit, with the productive interval of each proposed horizontal well shall be no closer than 150 feet from the boundaries of the unit for the Niobrara and Fort Hays Formations and no closer than 300 feet from the boundaries of the unit for the Codell and Carlile Formations; and all horizontal wells shall be no closer than 150 feet from the treated interval of another well producing from the same supply within the unit, unless an exception is granted by the Director. The Upland pending APDs for the Wells fall within the proposed approximate 1,280-acre drilling and spacing unit pending a Commission hearing.
- Certain provisions of the Colorado Oil and Gas Conservation Act, C.R.S §34-60-101, *et seq.* apply to this Application.

One electronic (cogcc.hearings_unit@state.co.us), one original and two copies shall be filed with the Commission. **Anyone who files a protest or intervention must be able to participate in a prehearing conference during the week of October 15, 2018, if a prehearing conference is**

requested by the Applicant, or any person who has filed a protest or intervention. Pursuant to Rule 511., if the matter is uncontested, it may be approved without a hearing.
