NOTICE OF HEARING

APPLICATION

On August 30, 2018, and amended on August 31, 2018, Petroshare Corp. (Operator No. 10454) ("PetroShare" or "Applicant"), filed a verified application pursuant to § 34-60-116, C.R.S. ("Application"), for an order to:

1) Establish the Application Lands as an approximate 1,278.40-acre drilling and spacing unit for the horizontal well production of Codell-Niobrara Formations oil, gas and associated hydrocarbons;

2) Approve the drilling, completion and operation of up to 20 horizontal wells in the drilling and spacing unit so established, for the production of Codell-Niobrara Formations oil, gas and associated hydrocarbons;

3) Approve that the productive interval for any of the horizontal wells in the drilling and spacing unit so established be located no closer than 150 feet from the productive interval of any other wellbore located within the same, absent exception being granted by the Director or variance being granted by the Commission;

4) Approve that the productive interval for any of the horizontal wells in the drilling and spacing unit so established be located no closer than 460 feet from the boundary of the same, absent exception being granted by the Director or variance being granted by the Commission; and

5) Require that the permitted wells within the unit be drilled and operated from no more than one surface locations within the unit, or at legal locations on adjacent lands, without exception being granted by the Director.

- On April 27, 1998, the Commission adopted Commission Rule 318A, which among other things, allowed certain drilling locations to be utilized to drill or twin a well, deepen a well or recomplete a well and to commingle any or all Cretaceous Age Formations from the base of the Dakota Formation to the surface. Commission Rule 318A supersedes all prior Commission drilling and spacing orders affecting well location and density requirements of GWA wells. On December 5, 2005, Commission Rule 318A was amended to, among other things, allow interior infill and boundary wells to be drilled and wellbore spacing units to be established. On August 8, 2011, Commission Rule 318A was again amended, among other things, to address drilling of horizontal wells. The Application Lands are subject to Commission Rule 318A for the Codell-Niobrara Formations.

One electronic ([cogcc.hearings\\_unit@state.co.us](mailto:cogcc.hearings_unit@state.co.us)), one original and two copies shall be filed with the Commission. **Anyone who files a protest or intervention must be able to participate in a prehearing conference during the week of October 15, 2018, if a prehearing conference is requested by the Applicant, or any person who has filed a protest or intervention.** Pursuant to Rule 511., if the matter is uncontested, it may be approved without a hearing.
