APPLICATION

On August 30, 2018, Kerr-McGee Oil & Gas Onshore LP (Operator No. 47120) ("Kerr-McGee" or "Applicant"), filed a verified application pursuant to §34-60-116, C.R.S., for an order to:

- 1) Pool all interests in three approximate 800-acre designated horizontal wellbore spacing units, established for the Application Lands, for the development and operation of the Niobrara and Codell Formations; and
- 2) Subject any nonconsenting interests to the cost recovery provisions of §34-60-116(7), C.R.S., effective as of the earlier of the date of the Application, or the date that any of the costs specified in §34-60-116(7)(b), C.R.S., were first incurred for the drilling of the:
 - a. Castle Pines 19-8HZ (API No. to be assigned) - Niobrara Formation - WSU No. 1;
 - b. Castle Pines 19-10HZ (API No. to be assigned) - Codell Formation - WSU No. 2.
 - c. Castle Pines 19-12HZ (API No. to be assigned) - Niobrara Formation - WSU No. 3.
