APPLICATION

On August 31, 2018, Great Western Operating Company, LLC (Operator No. 10110) ("Great Western" or "Applicant"), filed a verified application pursuant to §34-60-116, C.R.S. for an order to:

- 1) Establish an approximate 1,280-acre drilling and spacing unit for Sections 33 and 34, Township 4 North, Range 68 West, 6th P.M., for the production of oil, gas and associated hydrocarbons from the Niobrara and Codell Formations in the unit; and
- 2) Approve a total of up to 26 horizontal wells in the unit, for the production of oil, gas and associated hydrocarbons from the Niobrara and Codell Formations; and
- 3) Provide that the productive interval of any horizontal well shall be no closer than 460 feet from the boundaries of the unit and not less than 150 feet from the productive interval of another well within the unit, and authorize up to one well pad within the unit or adjacent thereto, unless an exception is granted by the Director; and
- 4) Find that an approximate 1,280-acre drilling and spacing unit for the development of the Codell and Niobrara Formations on the Application Lands will prevent waste, protect correlative rights, and maximize the efficient and economic production of the Niobrara and Codell Formations on the Application Lands; and
- 5) For such other findings and orders as the Commission may deem proper or advisable in this matter.

- On April 27, 1998, the Commission adopted Rule 318A, the Greater Wattenberg Area Special Well Location, Spacing and Unit Designation Rule.

- On February 19, 1992 (amended August 20, 1993), the Commission entered Order No. 407-87, which among other things, established 80-acre drilling and spacing units for the production of oil, gas and associated hydrocarbons from the Codell and Niobrara Formations, with the permitted well locations in accordance with the provisions of Order No. 407-1. Sections 33 and 34, Township 4 North, Range 68 West, 6th P.M. are subject to this Order for the Niobrara and Codell Formations.

One electronic (cogcc.hearings_unit@state.co.us), one original and two copies shall be filed with the Commission. **Anyone who files a protest or intervention must be able to participate in a prehearing conference during the week of December 3, 2018, if a prehearing conference is requested by the Applicant, or any person who has filed a protest or intervention.** Pursuant to Rule 511., if the matter is uncontested, it may be approved without a hearing.
