## NOTICE OF HEARING

TO ALL INTERESTED PARTIES AND TO WHOM IT MAY CONCERN:

### <u>APPLICATION LANDS</u>

Township 7 North, Range 60 West, 6th P.M. Section 4: All

#### APPLICATION

On September 11, 2018, Verdad Resources, LLC (Operator No. 10651) ("Verdad" or "Applicant") filed a verified application pursuant to §34-60-116, C.R.S., for an order to:

- 1) Modify an approximate 640-acre drilling and spacing unit for the Application Lands to include the Fort Hays, Codell, and Carlile Formations, and to approve ten additional wells, for a total of sixteen horizontal wells within the unit, with well location rules such that the treated interval of each wellbore within the unit shall be located no closer than 300 feet from the unit boundaries, and no closer than 150 feet from the productive interval of any other wellbore located within the unit, unless an exception is granted by the Director.
- 2) Require that the wells be drilled and operated from three surface locations within the unit or from legal locations on adjacent lands, without exception granted by the Director.

#### APPLICABLE ORDERS AND RULES

- Rule 318.a. provides that for unspaced lands, a well drilled in excess of 2,500 feet in depth shall be located not less than 600 feet from any lease line, and shall be located not less than 1,200 feet from any other producible or drilling oil or gas well when drilling to the same source of supply, unless authorized by order of the Commission upon hearing.
- On August 12, 2011, the Commission entered Order No. 535-51, which, among other things, established an approximate 640-acre drilling and spacing unit for Section 4, Township 7 North, Range 60 West, 6<sup>th</sup> P.M., and approved one horizontal well within the unit, for the production of oil, gas and associated hydrocarbons from the Niobrara Formation, with the treated interval of the wellbores located no closer than 600 feet from the unit boundaries without exception being granted by the Director.
- On August 12, 2011, the Commission entered Order No. 535-65, which established two approximate 640-acre drilling and spacing units for Section 4 and Section 17, Township 7

North, Range 60 West, 6th P.M., and approved two horizontal wells within each unit, for the production of oil, gas and associated hydrocarbons from the Niobrara Formation, with the treated interval of the wellbores located no closer than 600 feet from the unit boundaries without exception being granted by the Director.

On January 7, 2013, the Commission entered Order No. 535-238, which approved up to a total of six horizontal wells within each of ten approximate 640-acre drilling and spacing units for certain lands in Townships 7, 8, and 9 North, Ranges 58, 60, 61 and 62 West, 6th P.M., for the production of oil, gas and associated hydrocarbons from the Niobrara Formation, with the treated interval of the horizontal wellbore located no closer than 600 feet from the unit boundaries, and no closer than 600 feet from the treated interval of any other wellbore located in the unit, without exception being granted by the Director.

Anyone who files a protest or intervention must be able to participate in a prehearing conference during the week of December 3, 2018, if a prehearing conference is requested by the Applicant, or any person who has filed a protest or intervention. Pursuant to Rule 511., if the matter is uncontested, it may be approved without a hearing.
