APPLICATION

On September 14, 2018, amended November 5, 2018, Morning Gun Exploration LLC (Operator No. 10656) ("Morning Gun" or "Applicant") filed a verified application pursuant to §34-60-116, C.R.S., for an order to:

- 1) Vacate an approximate 640-acre drilling and spacing unit established by Order No. 535-69 for Section 2, Township 7 North, Range 59 West, 6th P.M.
- 2) Establish an approximate 1,280-acre drilling and spacing unit for the Application Lands, and approve up to 12 horizontal wells within the unit, for the production of oil, gas, and associated hydrocarbons from the Niobrara, Fort Hays, Codell and Carlile Formations, with the productive interval of the horizontal wells within each unit located no closer than 150 feet from the productive interval of any other horizontal wellbore within the unit, and no closer than 600 feet from the unit boundaries, without exception being granted by the Director.
- 3) Provide for up to two well pad locations for the horizontal wells within the Application Lands for the production of oil, gas, and associated hydrocarbons from the Niobrara, Fort Hays, Codell and Carlile Formations underlying the Application Lands, without exception being granted by the Director.

APPLICABLE ORDERS AND RULES

- Rule 318.a. provides that for unspaced lands, a well drilled in excess of 2,500 feet in depth shall be located not less than 600 feet from any lease line, and shall be located not less than 1,200 feet from any other producible or drilling oil or gas well when drilling to the same source of supply, unless authorized by order of the Commission upon hearing.
- On September 23, 2011, the Commission entered Order No. 535-69, which established 40 approximate 640-acre drilling and spacing units covering various lands, including

Section 2, Township 7 North, Range 59 West, 6th P.M., and approved two horizontal wells within each unit for production from the Niobrara Formation, with the treated interval of the wellbore for the permitted wells to be located no closer than 600 feet from the unit boundaries, and no closer than 150 feet from any existing or permitted oil or gas wellbore, unless an exception is authorized by the Director.

One electronic (cogcc.hearings_unit@state.co.us), one original and two copies shall be filed with the Commission. **Anyone who files a protest or intervention must be able to participate in a prehearing conference during the week of December 3, 2018, if a prehearing conference is requested by the Applicant, or any person who has filed a protest or intervention.** Pursuant to Rule 511., if the matter is uncontested, it may be approved without a hearing.
