APPLICATION

On October 18, 2018, Noble Energy, Inc. (Operator No. 100322) ("Noble" or "Applicant"), filed a verified application pursuant to §34-60-116, C.R.S., for an order to:

1) Amend Pooling Order No. 407-2322 to account for the adjustment to WSU No. 2, the Bison Ridge Y22-756 Well (API No. 05-123-45370) and thereby pool the interests in the Application Lands, being an approximate 320-acre wellbore spacing unit for development and operation of the Codell and Carlile Formations, effective as of the earlier of the date of Pooling Order No. 407-2322, or the date the costs specific in §34-60-116(7)(b), C.R.S., are first incurred for the drilling of the Bison Ridge Y22-756 Well.

- On April 27, 1998, the Commission adopted Rule 318A, the Greater Wattenberg Area Special Well Location, Spacing and Unit Designation Rule.
- On January 29, 2018, the Commission entered Order No. 407-2322 which, among other things, pooled all interests in two approximate 720-acre horizontal wellbore spacing units, for portions of Sections 10, 15 and 22, Township 2 North, Range 64 West, 6th P.M., for the development and operation of the Codell and Niobrara Formations:


Additional information about the hearing on this Application will be in the Commission's Agenda, which is posted on the Commission website approximately three days before the hearing.

One electronic (cogcc.hearings_unit@state.co.us), one original and two copies shall be filed with the Commission. **Anyone who files a protest or intervention must be able to participate in a prehearing conference during the week of December 3, 2018, if a prehearing conference is requested by the Applicant, or any person who has filed a protest or intervention.** Pursuant to Rule 511., if the matter is uncontested, it may be approved without a hearing.
