On October 18, 2018, Extraction Oil & Gas, Inc. (Operator No. 10459) ("Extraction" or "Applicant"), filed a verified application pursuant to §34-60-116, C.R.S., for an order to:

- 1) Establish an approximate 960-acre drilling and spacing unit for the Application Lands, for production of oil, gas, and associated hydrocarbons from the Niobrara and Codell Formations;
- 2) Approve the drilling of up to ten horizontal wells in the proposed unit, to be drilled in a north/south orientation;
- 3) Allow any horizontal wells to be drilled under this Application for production from the Niobrara and Codell Formations will be drilled from the surface of the drilling unit, or on adjacent lands with consent of the landowner, from no more than two surface locations, unless an exception is granted by the Director;
- 4) Allow the wellbores of any horizontal wells to be drilled under this Application may enter the Niobrara and Codell Formations anywhere within the unit, or on adjacent lands, without exception being granted by the Director; and
- 5) Allow the treated intervals of the wellbores to be no closer than 460 feet from the boundaries of the proposed unit, with an inter-well setback no closer than 150 feet from the treated interval of a well producing from the same formation.
