On October 18, 2018, Extraction Oil & Gas, Inc. (Operator No. 10459) ("Extraction" or "Applicant"), filed a verified application pursuant to §34-60-116, C.R.S., for an order to:

1) Declare Order No. 407-2497, pooling all interests in an approximate 280-acre wellbore spacing unit established for the Application Lands applicable to all previously unnoticed parties.

- On June 11, 2018, the Commission entered Order No. 407-2497 which, among other things, pooled all interests in an approximate 280-acre designated horizontal wellbore spacing unit for the Application Lands, for the development and operation of the Niobrara Formation, and to subjected any nonconsenting interests to the cost recovery provisions of §34-60-116(7), C.R.S., for the drilling of the Enright 14N Well (API No. 05-123-46866).

One electronic (cogcc.hearings_unit@state.co.us), one original and two copies shall be filed with the Commission. **Anyone who files a protest or intervention must be able to participate in a prehearing conference during the week of December 3, 2018, if a prehearing conference is requested by the Applicant, or any person who has filed a protest or intervention.** Pursuant to Rule 511., if the matter is uncontested, it may be approved without a hearing.
