On October 18, 2018, SRC Energy Inc. (Operator No. 10311) ("SRC" or "Applicant"), filed a verified application ("Application") pursuant to §34-60-116, C.R.S., for an order to:

- 1) Establish an approximate 937.15-acre drilling and spacing unit for the Application Lands, for production of oil, gas, and associated hydrocarbons from the Niobrara and Codell Formations;
- 2) Approve the drilling of 26 horizontal wells in the proposed unit, to be drilled in an east-west or west-east orientation, and
- 3) Allow the treated intervals of the wellbores to be no closer than 460 feet from the northern and southern boundaries of the proposed unit, no closer than 150 feet from the eastern and western boundaries of the proposed unit, with an inter-well setback of not less than 150 feet from the treated interval of a well producing from the Codell and Niobrara Formations.
- 4) Applicant states that any horizontal wells to be drilled in the unit will be drilled from no more than two multi-well pads on the surface of the drilling unit, or on adjacent lands with consent of the landowner, unless an exception is granted by the Director


Additional information about the hearing on this Application will be in the Commission's Agenda, which is posted on the Commission website approximately three days before the hearing.
