NOTICE OF HEARING

On October 18, 2018, Verdad Resources LLC (Operator No. 10651) ("Verdad" or "Applicant"), filed a verified application ("Application") pursuant to §34-60-116, C.R.S., for an order to:

- 1) Establish an approximate 1,280-acre drilling and spacing unit for the Application Lands and approve up to 16 horizontal wells in the proposed unit, for production of oil, gas, and associated hydrocarbons from the Niobrara and Codell Formations, with the productive interval of any horizontal well permitted under this Application located no less than 460 feet from the unit boundaries and no less than 150 feet from the productive interval of any wellbore within the same unit, unless an exception is granted by the Director; and
- 2) Require that the wells be drilled from no more than three surface locations within the unit or on adjacent lands, unless an exception is granted by the Director.

- On April 27, 1998, the Commission adopted Rule 318A, the Greater Wattenberg Area Special Well Location, Spacing and Unit Designation Rule. Sections 14 and 15 of Township 1 South, Range 66 West, 6th P.M., are subject to this rule for the Niobrara and Codell Formations.
- On February 19, 1992, the Commission entered Order No. 407-87 (amended August 20, 1993) which, among other things, established 80-acre drilling and spacing units for the production of oil, gas, and associated hydrocarbons from the Codell-Niobrara Formations, the Codell Formation, and the Niobrara Formation underlying certain lands including Sections 14 and 15 of Township 1 South, Range 66 West, 6th P.M., with the permitted well locations in accordance with the provisions of Order No. 407-1.

One electronic (cogcc.hearings_unit@state.co.us), one original and two copies shall be filed with the Commission. **Anyone who files a protest or intervention must be able to participate in a prehearing conference during the week of December 3, 2018, if a prehearing conference is requested by the Applicant, or any person who has filed a protest or intervention.** Pursuant to Rule 511., if the matter is uncontested, it may be approved without a hearing.
