APPLICATION

On October 18, 2018, PDC Energy, Inc. (Operator No. 69175) ("PDC" or "Applicant"), filed a verified application pursuant to §34-60-116, C.R.S. for an order to:

1) Amend Order No. 407-1821 to apply only to the as-drilled acreage, consisting of the Application Lands, for the Dunn 7L-221 Well (API No. 05-123-42827), drilled to develop the Niobrara Formation.

APPLICABLE ORDERS AND RULES

- On April 27, 1998, the Commission adopted Rule 318A, the Greater Wattenberg Area Special Well Location, Spacing and Unit Designation Rule. Sections 6 and 7, Township 5 North, Range 64 West, 6th P.M., and Section 31, Township 6 North, Range 64 West, 6th P.M., are subject to this Rule for the Niobrara Formation.
- On February 19, 1992, the Commission entered Order No. 407-87 (amended August 20, 1993) which, among other things, established 80-acre drilling and spacing units for the production of oil, gas, and associated hydrocarbons from the Codell-Niobrara Formations, the Codell Formation, and the Niobrara Formation underlying certain lands, including Sections 6 and 7, Township 5 North, Range 64 West, 6th P.M., and Section 31, Township 6 North, Range 64 West, 6th P.M., with the permitted well locations in accordance with the provisions of Order 407-1.
- On October 24, 2016, the Commission entered Order No. 407-1823, which, among other things, pooled all non-consenting interests in an approximate 640-acre wellbore spacing unit for the S $\frac{1}{2}$ S $\frac{1}{2}$ of Section 7, S $\frac{1}{2}$ S $\frac{1}{2}$ of Section 8, N $\frac{1}{2}$ N $\frac{1}{2}$ of Section 17, and the N $\frac{1}{2}$ N $\frac{1}{2}$

of Section 18, Township 5 North, Range 64 West, 6th P.M., for the HOP 18E-232 Well (API No. 05-123-43160), from the Niobrara Formation. Order No. 407-1823 is not affected by this Application, and proceeds from any shared lands will be accounted for in the production of the Well.

- On October 24, 2016, the Commission entered Order No. 407-1821, which, among other things, pooled all non-consenting interests in an approximate 720-acre wellbore spacing unit for the W½ of Section 6 and the W½ of Section 7, Township 5 North, Range 64 West, 6th P.M., and the S½SW¼ of Section 31, Township 6 North, Range 64 West, 6th P.M., for the Dunn 7L-221 Well (API No. 05-123-42827), from the Niobrara Formation. This Application seeks to amend Order No. 407-1821 to apply on to the as-drilled acreage for the Dunn 7L-221 Well.


Additional information about the hearing on this Application will be in the Commission's Agenda, which is posted on the Commission website approximately three days before the hearing.

One electronic (cogcc.hearings_unit@state.co.us), one original and two copies shall be filed with the Commission. **Anyone who files a protest or intervention must be able to participate in a prehearing conference during the week of December 3, 2018, if a prehearing conference is requested by the Applicant, or any person who has filed a protest or intervention.** Pursuant to Rule 511., if the matter is uncontested, it may be approved without a hearing.
