On October 26, 2018, PDC Energy, Inc. (Operator No. 69175) ("PDC" or "Applicant"), filed a verified application pursuant to §34-60-116, C.R.S. for an order to:

1) Vacate Order No. 407-2136, which pooled all interests within an approximate 440.00-acre wellbore spacing unit for the drilling of the Josephine 19O-314 Well (API No. 05-123-44680) ("Well"), for the development of the Niobrara Formation.

- On July 24, 2017, the Commission entered Order No. 407-2136, which, among other things, originally pooled all interests in an approximate 440-acre wellbore spacing unit consisting of the SW $\frac{1}{4}$ NE $\frac{1}{4}$, S $\frac{1}{2}$ NW $\frac{1}{4}$, N $\frac{1}{2}$ SW $\frac{1}{4}$ of Section 19, Township 5 North, Range 64 West, 6th P.M., and the SE $\frac{1}{4}$ NW $\frac{1}{4}$, S $\frac{1}{2}$ NE $\frac{1}{4}$, NE $\frac{1}{4}$ SW $\frac{1}{4}$, N $\frac{1}{2}$ SE $\frac{1}{4}$ of Section 24, Township 5 North, Range 65 West, 6th P.M., for the Josephine 19O-314 Well (API No. 05-123-44680), for the development and operation of the Niobrara Formation, and applied the cost recovery provisions of C.R.S. § 34-60-116(7) to any working interest owner or unleased owner that did not elect to participate in the Well.


Additional information about the hearing on this Application will be in the Commission's Agenda, which is posted on the Commission website approximately three days before the hearing.
