### **APPLICATION**

On November 29, 2018, SRC Energy Inc. (Operator No. 10311) ("SRC" or "Applicant") filed a verified application pursuant to §34-60-116, C.R.S., for an order to:

- 1) Establish an approximate 1,611-acre drilling and spacing unit for the Application Lands, for production of oil, gas, and associated hydrocarbons from the Niobrara and Codell Formations:
- 2) Approve the drilling of 26 horizontal wells in the proposed unit, to be drilled in an east/west orientation;
- 3) Require that any horizontal wells to be drilled under this Application for production from the Niobrara and Codell Formations will be drilled from the surface of the drilling unit, or on adjacent lands with consent of the landowner, from no more than one surface location, unless an exception is granted by the Director;
- 4) Allow the wellbores of any horizontal wells to be drilled under this Application may enter the Niobrara and Codell Formations anywhere within the unit, or on adjacent lands, without exception being granted by the Director; and
- 5) Require that the treated intervals of the wellbores to be no closer than 460 feet from the northern, southern, and western boundaries of the proposed unit and no closer than 150 feet from the eastern boundaries of the proposed unit, with an inter-well setback no closer than 150 feet from the treated interval of any well producing from the same formation.
