NOTICE OF HEARING

Noble Energy, Inc. (Operator No. 100322) ("Applicant"), filed an Application with the Commission for an order to establish a drilling and spacing unit, as well as to set the maximum number of wells that may be drilled in the proposed unit on lands identified below. This Notice was sent to you because the Applicant believes you may own oil or gas ("mineral") interests within the proposed unit. Generally, spacing is the process whereby an applicant obtains Commission approval to assign certain mineral interests to be developed by a specific number of wells. Importantly, spacing is not pooling, and it is not an application for a drilling permit.

Anyone who files a protest or intervention must be able to participate in a prehearing conference during the week of February 25, 2019, if a prehearing conference is requested by the Applicant or by any person who has filed a protest or intervention.


