No depth to groundwater data is available for the nearest water well. The depth to groundwater of 25 feet was taken from the nearest water well with data (Perm No. 26343) which is located approximately 1.2 miles northwest of the proposed location. The final use reference area is immediately adjacent to the location as indicated in the "north" photograph.
