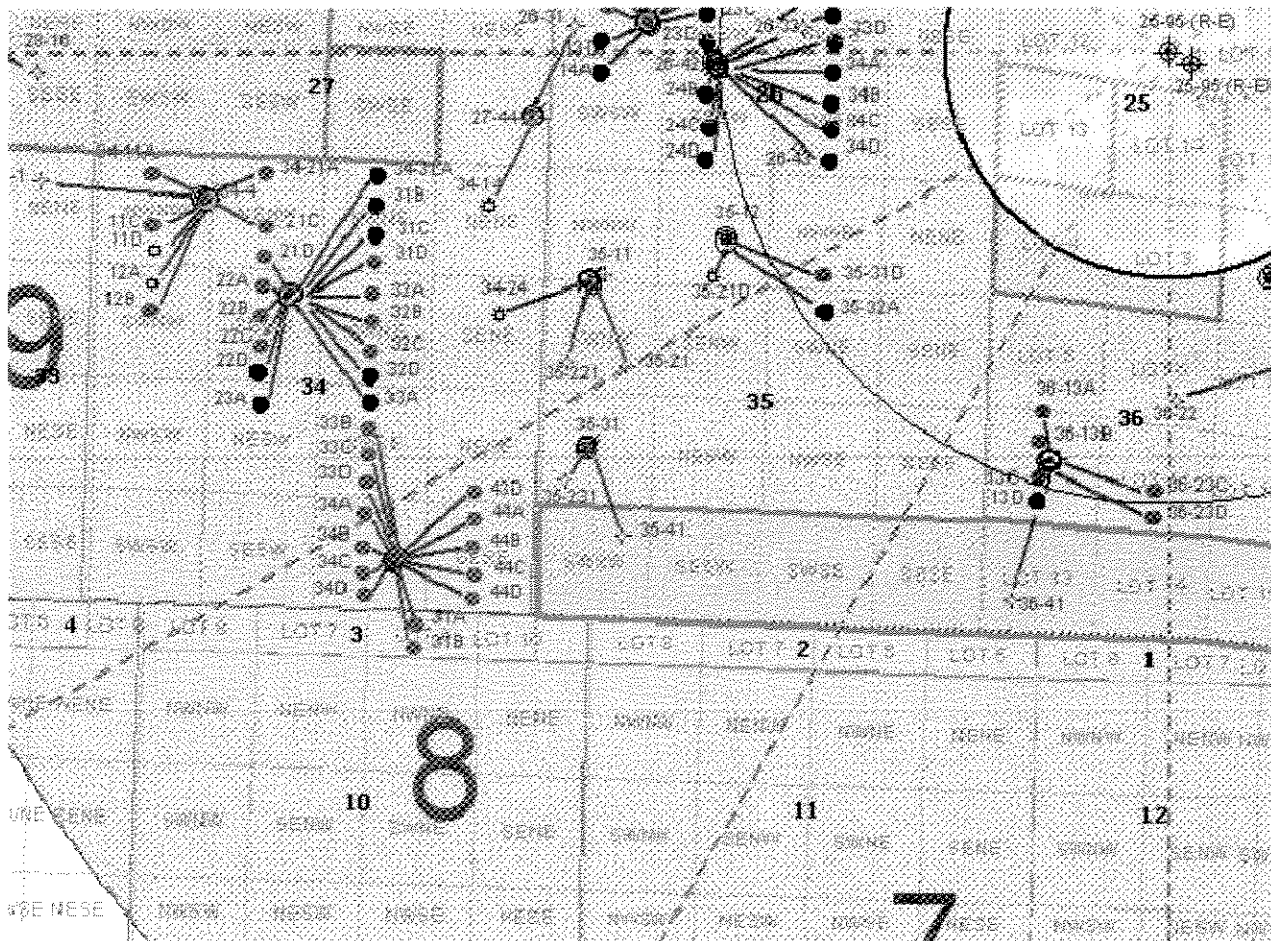

Noble has submitted refile permit applications for all 14 wells on a pad in the SWSE Section 34 7S 95W. The surface location is approximately 2.05 miles from the project well in Tier 2 of the Project Rulison SAP. The BHLs range from 1.82 to 2.16 miles from the project well in Tier 2 and Sectors 8 and 9 of the Project Rulison SAP. The surface and the minerals are fee for all the wells. The permit packets contain a letter from Noble to Jack dated Dec. 9, 2009. The well list spread sheet is attached. Please let me know if you need any additional information.

At this time, DOE does not request any additional information but would encourage COGCC to place general language in the permit such that the company would accommodate DOE sampling requests in the future. DOE agrees with the COGCC assessment that the pad is located approximately 2.05 miles from the Rulison site located at SWSE Section 34 7S 95W, and the bottom-hole-locations range approximately from 1.82 to 2.16 miles from Project Rulison. Accordingly, DOE agrees with COGCC that all wells fall under the Tier 2 sampling and monitoring of the COGCC Rulison Sample and Analysis Plan and one well is located in Sectors 8

and of the Rulison SAP. DOE will continue to review the proposed locations and subsurface orientations of the propose drilling for documentation when sampling occurs.
