


Dear Mr. and Mrs. Schlagel & Mr. and Mrs. Schlagel:

Noble Energy, Inc. ("Noble") plans to drill the UPV P05-21D well (the "Well") at the referenced location which is more specifically described as 2511 feet FSL, and 2306 feet FEL which is outside the drilling window prescribed in Colorado Oil and Gas Conservation Commission ("COGCC") Rule 318A.a.(1).


By signing this letter you hereby grant your consent to Noble to locate the Well outside of a GWA window as defined in COGCC Rule 318A.a and waive the directional drilling requirement under Rule 318A.e. Additionally, the Well is being proposed at a surface location approximately 833 feet from an existing surface well location. By signing this letter you also grant your consent to Noble to locate the Well more than 50 feet from the existing well as provided for under COGCC Rule 318A.c.(2).





The governmental 1/4 Section has less than 8 bottom hole wells producing from the Codell, Niobrara, & J-Sand Formations.




I hereby state that this Well Location Certificate was prepared by me, or under my direct supervision, that the fieldwork was completed on 8-27-09, for and on behalf of Noble Energy Inc. That this is not a Land Survey Plat or an Improvement Survey Plat, and that it is not to be relied upon for establishment of fence, building, or other future improvement lines.
