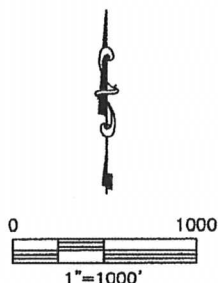
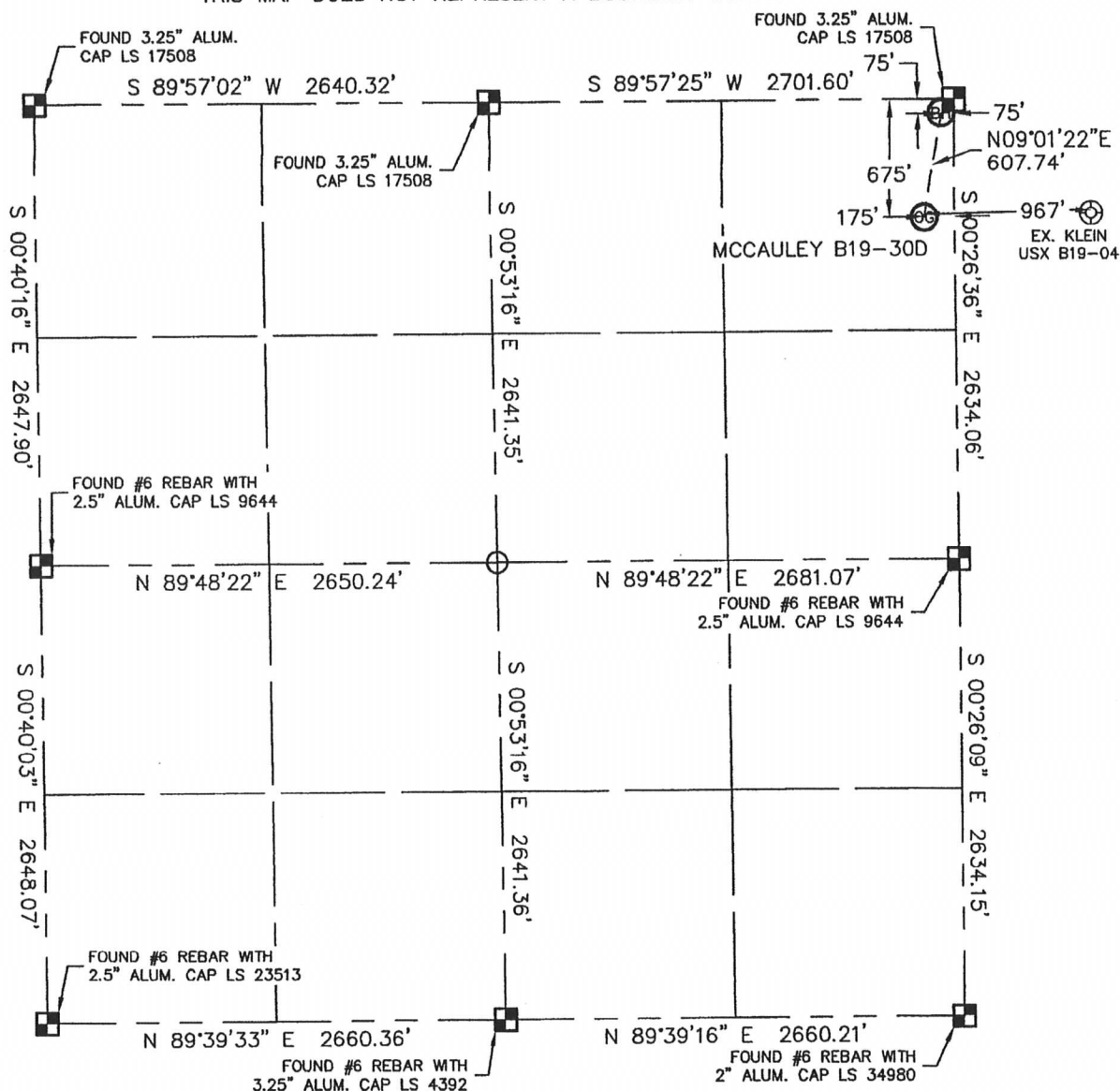


WELL LOCATION CERTIFICATE

In accordance with a request from Matt Campbell with Noble Energy Inc., Lat40°, LLC has determined the surface location of the MCCAULEY B19-30D to be 675' from the NORTH line and 175' from the EAST line and the bottom hole to be 75' from the NORTH line and 75' from the EAST line as measured at right angles from the section line of Section 24, Township 5 North, Range 65 West of the Sixth Principal Meridian, County of Weld, State of Colorado.

I hereby state that this Well Location Certificate was prepared by me, or under my direct supervision, that the fieldwork was completed on 8/11/10, for and on behalf of Noble Energy Inc. That this is not a Land Survey Plat or an Improvement Survey Plat, and that it is not to be relied upon for establishment of fence, building, or other future improvement lines.

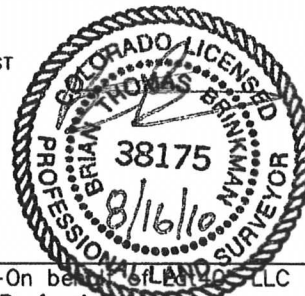

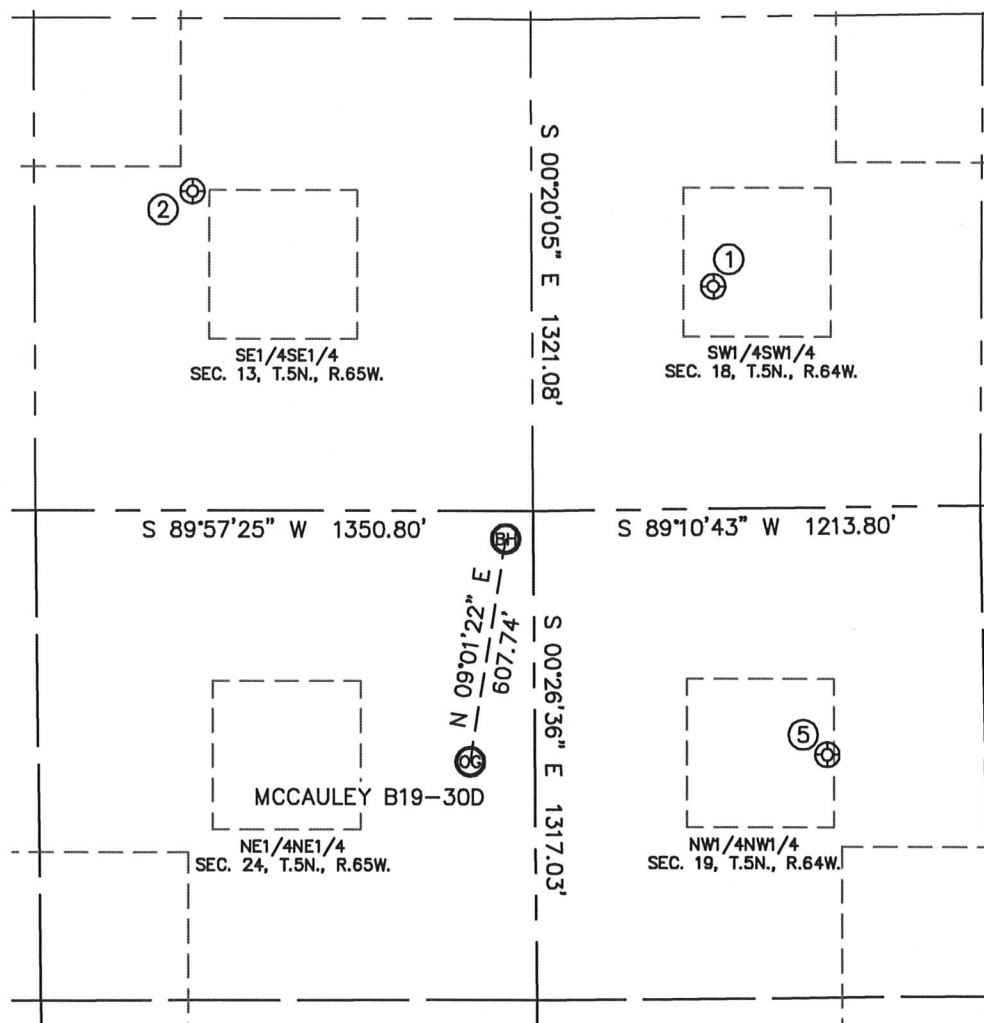
