CONSTRUCTION LAYOUT DRAWING 3 OF 3

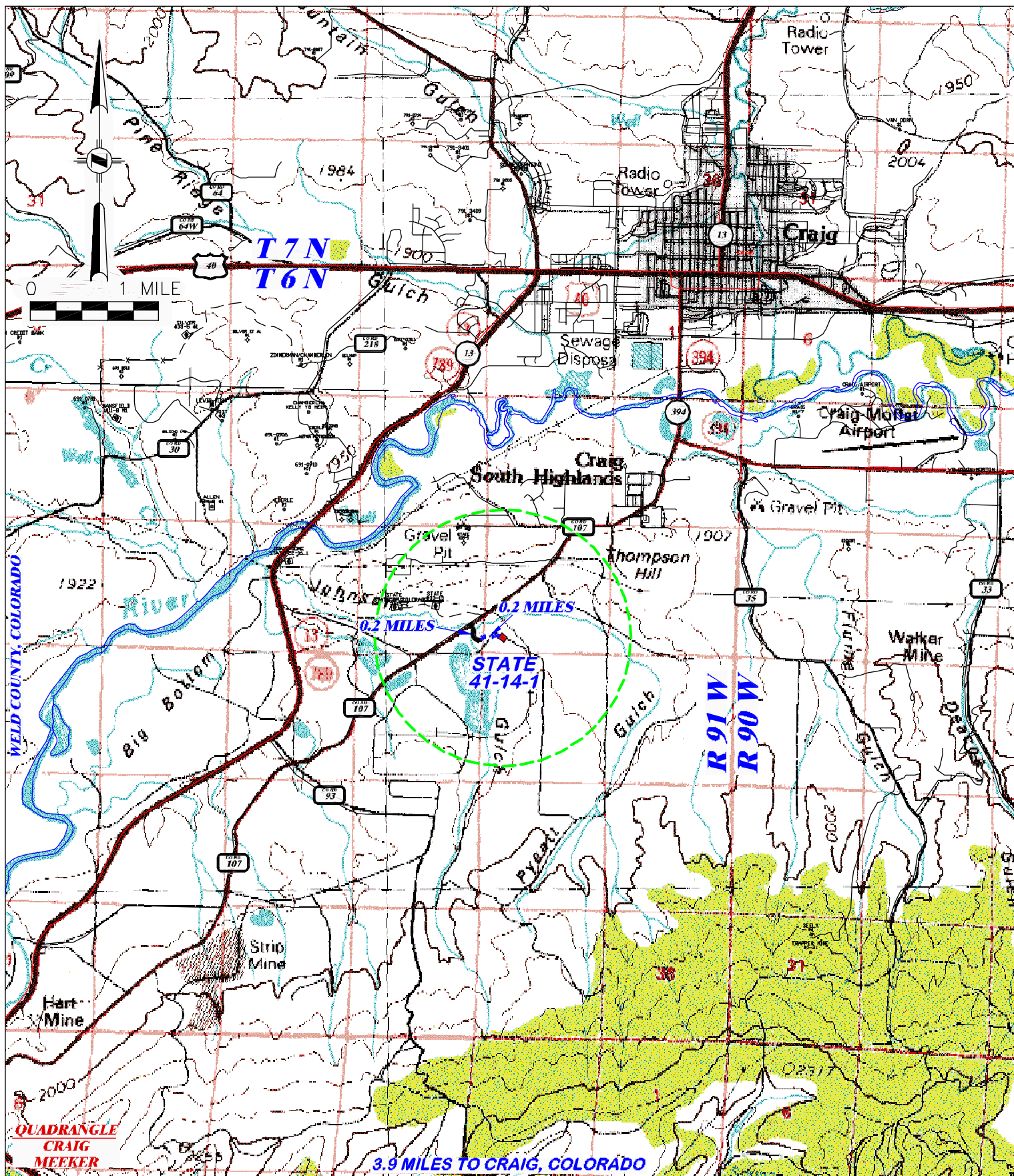
