


**SURVEY DESCRIPTION:**

A STRIP OF LAND, 30.00 FEET IN WIDTH FOR A PROPOSED ROAD RIGHT-OF-WAY, ALL SITUATED IN THE SOUTHEAST QUARTER OF THE SOUTHWEST QUARTER OF SECTION 16, TOWNSHIP 9 NORTH, RANGE 66 WEST, 6TH PRINCIPAL MERIDIAN, WELD COUNTY, COLORADO, THE BOUNDARIES THEREOF BEING 15.00 FEET ON EITHER SIDE OF THE FOLLOWING DESCRIBED CENTERLINE:

**COMMENCING** AT THE SECTION CORNER COMMON TO SECTIONS 16, 17, 20 AND 21, TOWNSHIP 9 NORTH, RANGE 66 WEST, 6TH PRINCIPAL MERIDIAN, WELD COUNTY, COLORADO, BEING AN ALUMINUM CAP MONUMENT, THENCE NORTH 85°09'24" EAST, 1834.20 FEET TO THE TRUE POINT OF BEGINNING;  
THENCE SOUTH 00°48'48" EAST, 100.17 FEET TO THE POINT OF TERMINUS, SOUTH 88°29'28" WEST, 843.63 FEET FROM THE QUARTER SECTION CORNER COMMON TO SAID SECTIONS 16 AND 21, BEING AN ALUMINUM CAP MONUMENT.
