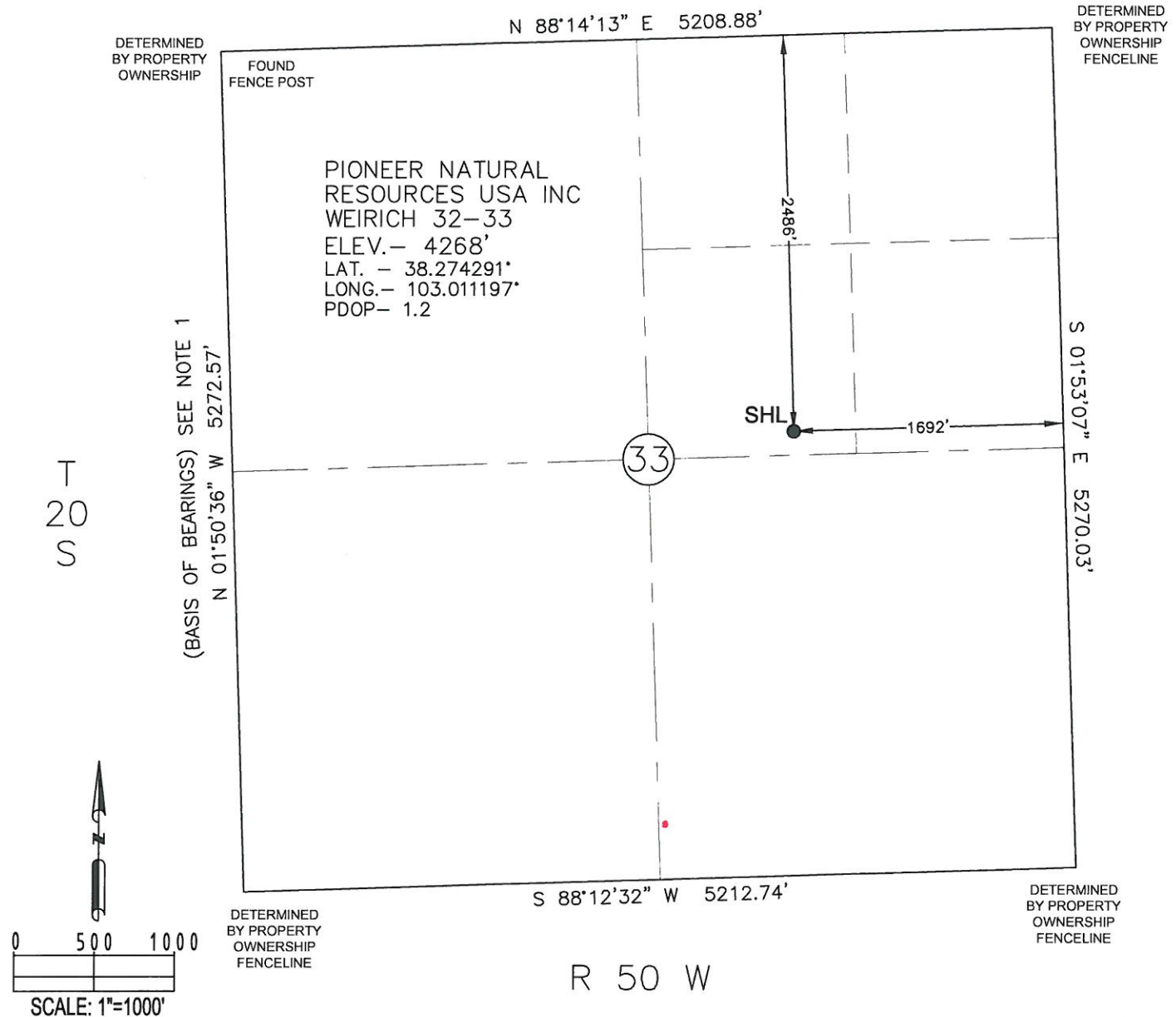


# WELL LOCATION CERTIFICATE
