33. Comments Nearest public road (270') is Morgan County Road 17. Nearest property line (280') is the western edge of the SW/4 of section 13, T1N R58W. Nearest well in the same formation (1303') is the Dewey #4. This well is currently a shut-in J sand producer in Adena field. Plan to set a CIBP and cement above the current J sand perfs and recomplete the well to the D sand. A form 2A is not required for this recompletion because no pit will be constructed and there will be no surface disturbance beyond the originally disturbed area. No conductor casing was set when this well was drilled; the casing consists of surface casing and a production string.
