1. That he is the Editor of The Adams County Sentinel, a weekly newspaper printed and published in the City of Brighton, County of Adams, and State of Colorado, and has personal knowledge of all the facts set forth in this affidavit.

2. That the said Adams County Sentinel is printed and published at regular intervals, one time each week on Thursday and that it has a general circulation in the County of Adams and elsewhere.

3. That the said Adams County Sentinel was established and has been printed and published in said county uninterruptedly and continuously during a period of at least fifty-two consecutive weeks next prior to the first issue thereof containing said publication, a copy of which is hereunto attached.

4. That the said Adams County Sentinel is a weekly newspaper of general circulation, and is printed and published in whole or in part in the said County of Adams in which said publication is required by law to be published, a copy of which is hereunto attached.

5. That said Adams County Sentinel is a weekly newspaper within the meaning of the act of the General Assembly of the State of Colorado, approved April 7, 1921, and entitled "An Act Concerning Legal Notices, Advertisement and Publications and the Fees of Printers and Publishers Thereof, and to Repeal All Acts and Parts of Acts in Conflict with the Provisions of this Act" and as amended by an act of said General Assembly, entitled, "An Act to Amend an Act Entitled, 'An Act Concerning Legal Notices, Advertisements and Publications and the Fees of Printers and Publishers Thereof, and to Repeal All Acts and Parts of Acts in Conflict with the Provisions of this Act,'" approved March 30, 1923, and as amended by an act of said General Assembly approved May 18, 1931, entitled, "An Act to Amend Section 4 of Chapter 139, Session Laws of Colorado, 1923, Relating to Legal Notices and Advertisements," which said Act took effect on and after the first day of January, 1932, and as amended by an act of said General Assembly, entitled, "An Act to Amend Chapter 139 of the Session Laws of 1923 Relating to Legal Notices and Advertisements; to Define Newspapers Qualified to Publish Legal Notices and Advertisements and the Fees of Printers and Publishers thereof, and to Provide that the Costs of such Legal Notices and Advertisements Shall Be Taxed as Fees," approved March 5, 1935; and as amended by an Act of Said General Assembly entitled, "An Act Relating to Legal Notices and Advertisements, and Amending Section 1 of Chapter 113, Session Laws of 1931," approved March 25, 1935.

Pursuant to said hearing in the above entitled matter, at the time and place aforesaid, or at any adjourned meeting, the Commission will enter such orders as it deems appropriate to prevent the waste of oil and gas, either or both, in the operation of said field, and to carry out the purposes of the statute.
