We apologize for the delay in land treatment activities. There has been a combination a factors that has delayed the activities between negotiating with landowners, scheduling the contractor, and procuring heavy equipment to perform the land treatment.

Beren is aware that this is not a desirable delay to remediation of the onsite stockpiles. As discussed, during this period a portion of impacted soil was hauled for disposal to allow for land treatment at one location in order to secure land owner approval.

Now that Beren has satisfied the conditions of approval required by the COGCC, we are ready to commence land treatment activities immediately upon receipt of authorization to proceed. We will continue to land treat the soil at each location simultaneously as long as we are seeing progress. Beren would like to get this soil remediated and disposed/reused as soon as possible.

The approved Form 27 presented a Remediation Start Date of March 1, 2013. The COAs requiring surface owner approval and reclamation extension were provided to Beren in January. Is there a reason it took nearly six months to get surface owner approval and request the extension? This work should have been well underway to take advantage of the warm months for land treatment. I'll have to discuss this with my manager and the enforcement unit. I'll provide a formal response next week.
