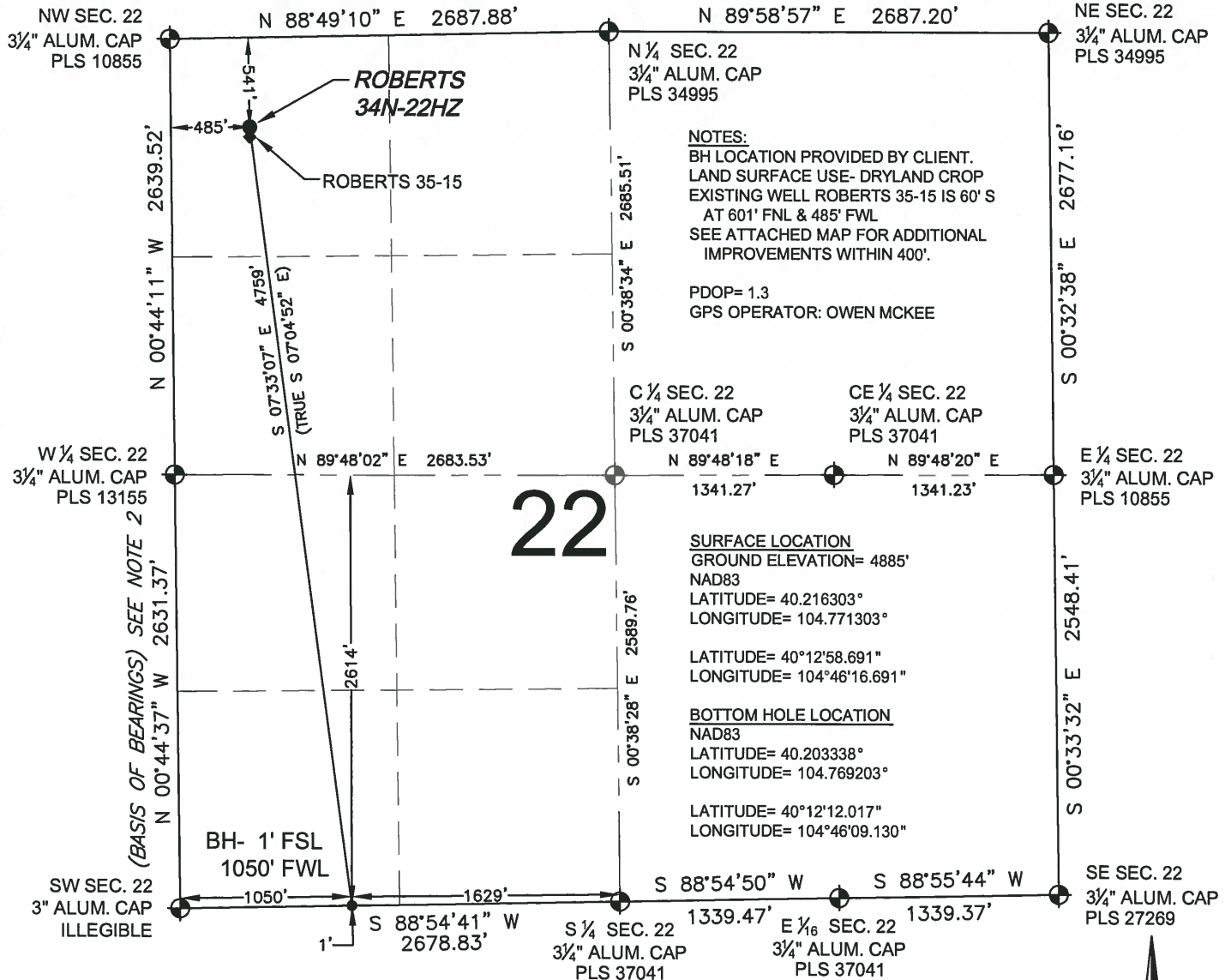


WELL LOCATION CERTIFICATE: ROBERTS 34N-22HZ

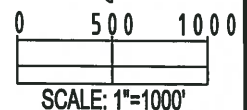
