
Dear Ms. Tarin,

In accordance with the requirement of Rule 305.f. of the Colorado Oil and Gas Conservation Commission (COGCC), this letter serves as notice by PDC Energy, Inc. (PDC) of its intention to conduct drilling operations with heavy equipment on the above-captioned wells not less than thirty (30) days from the date of this letter. This notice is following up on our conversations and discussions regarding the location of this well site(s), access roads, production facilities, MLVT area (temporary frac water area) and other related matters. However, the location(s) may be staked prior to this notice as discussed in consultation.

For purposes of this Notice Letter, our Initial Consultation meeting was held at the site on January 24, 2014. Pursuant to Rule 306, would you please complete (and return) the enclosed form requesting a consultation or to designate a representative for surface consultation for our records, even though the consultation has been completed? Additionally, enclosed please find a copy of the COGCC's brochure describing surface owner rights and responsibilities, and a copy of the COGCC's on-site inspection policy. Partial copies of the survey are also attached.

As the surface owner, you have the responsibility for notifying any affected tenant farmer, lessee or other party that may own or have an interest in any crops or surface improvements that could be affected by these proposed operations. A complete copy of the COGCC rules and policies is available at the following website: <http://cogcc.state.co.us/>. I have also enclosed Waiver Letters (related to the well locations) that after being signed will be attached to PDC's drilling permit application with the COGCC. It is requested that you sign (and return) these Waivers. Should you have any questions regarding our operations or this notice, please feel free to contact me at 303-517-3010.

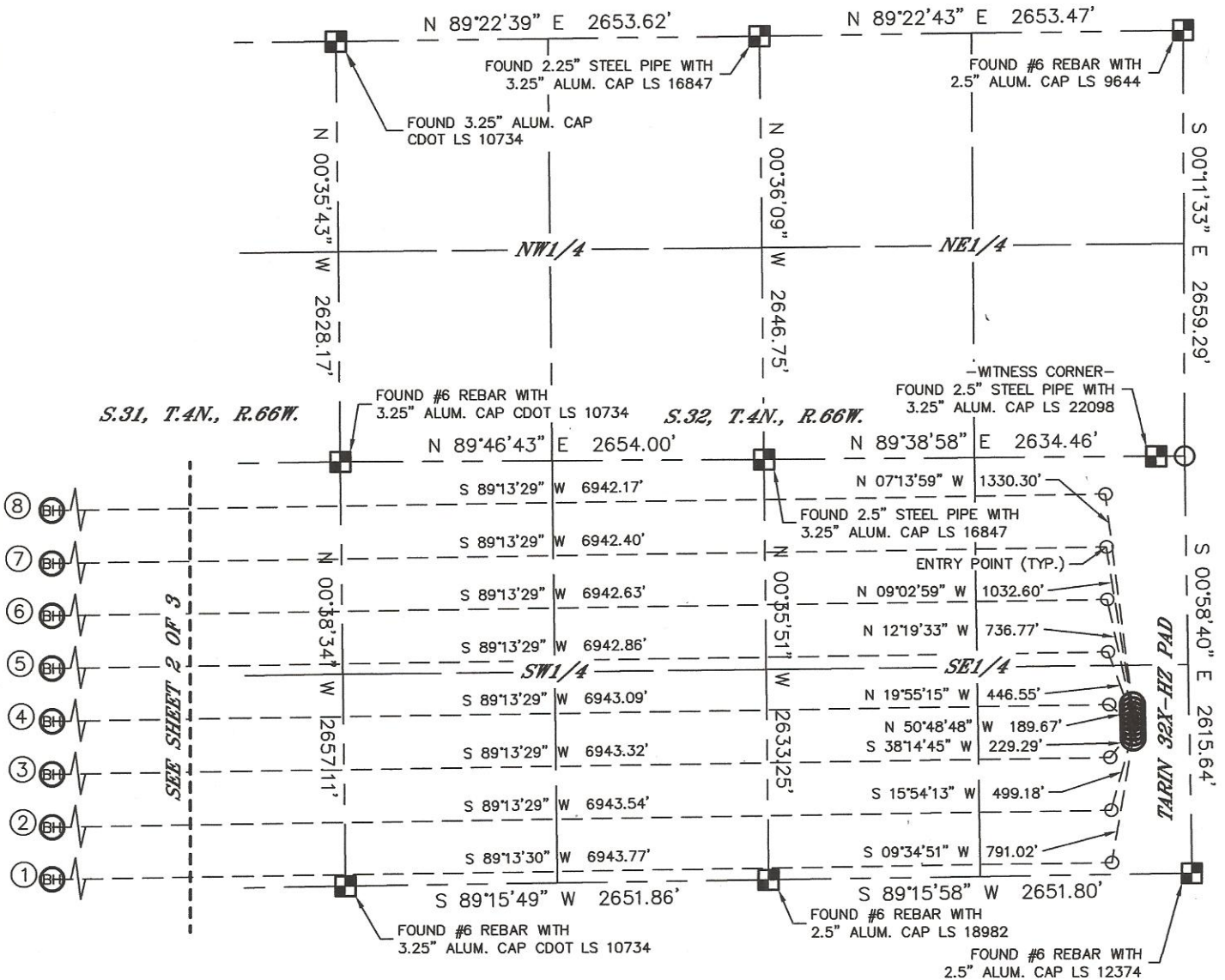

MULTI-WELL PLAN

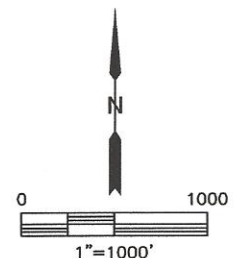
TARIN 32X-HZ PAD

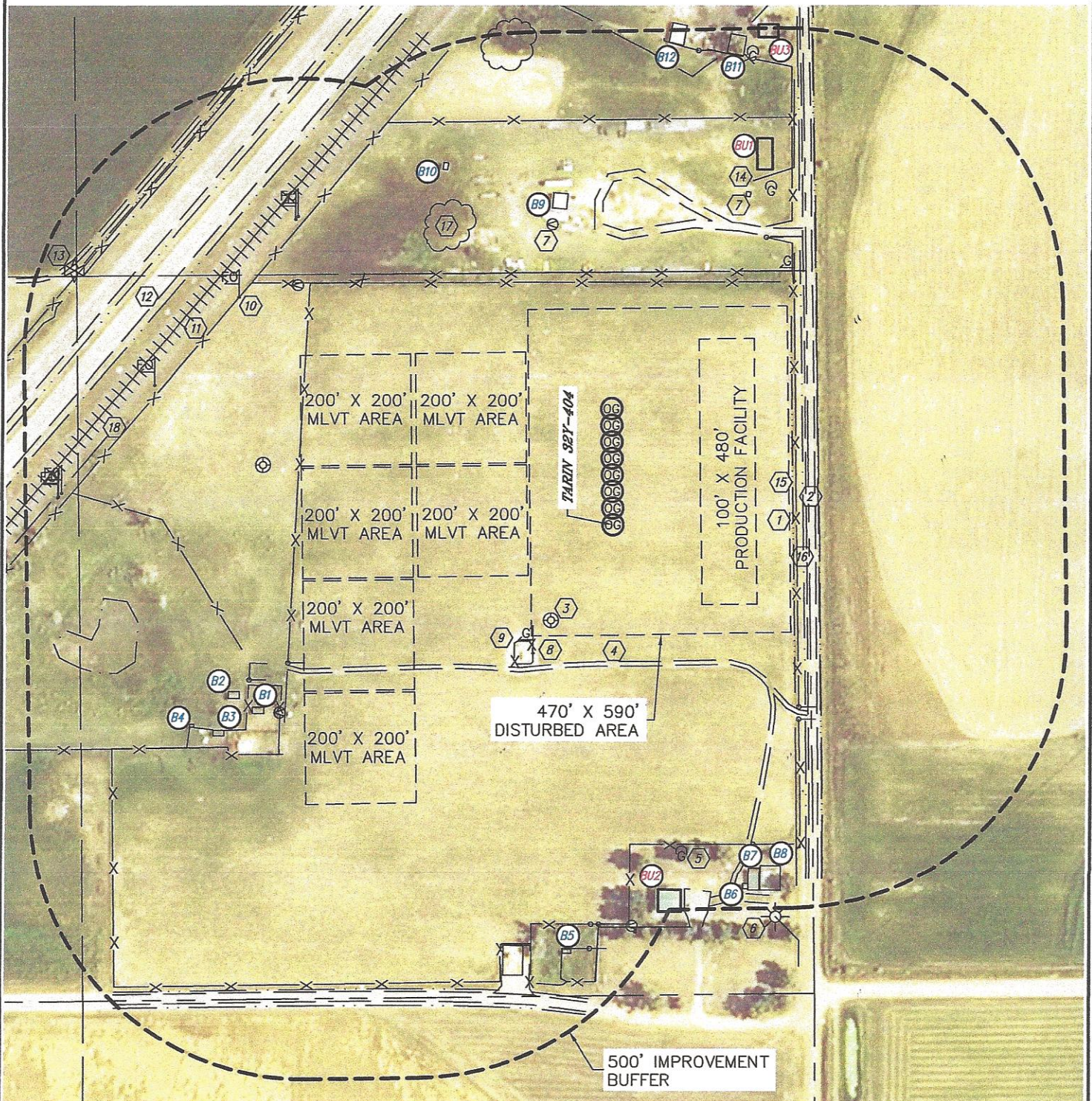

LOCATION DRAWING

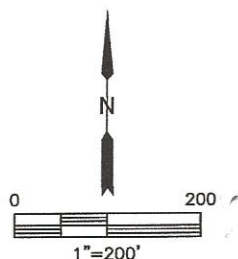

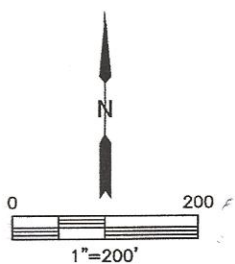

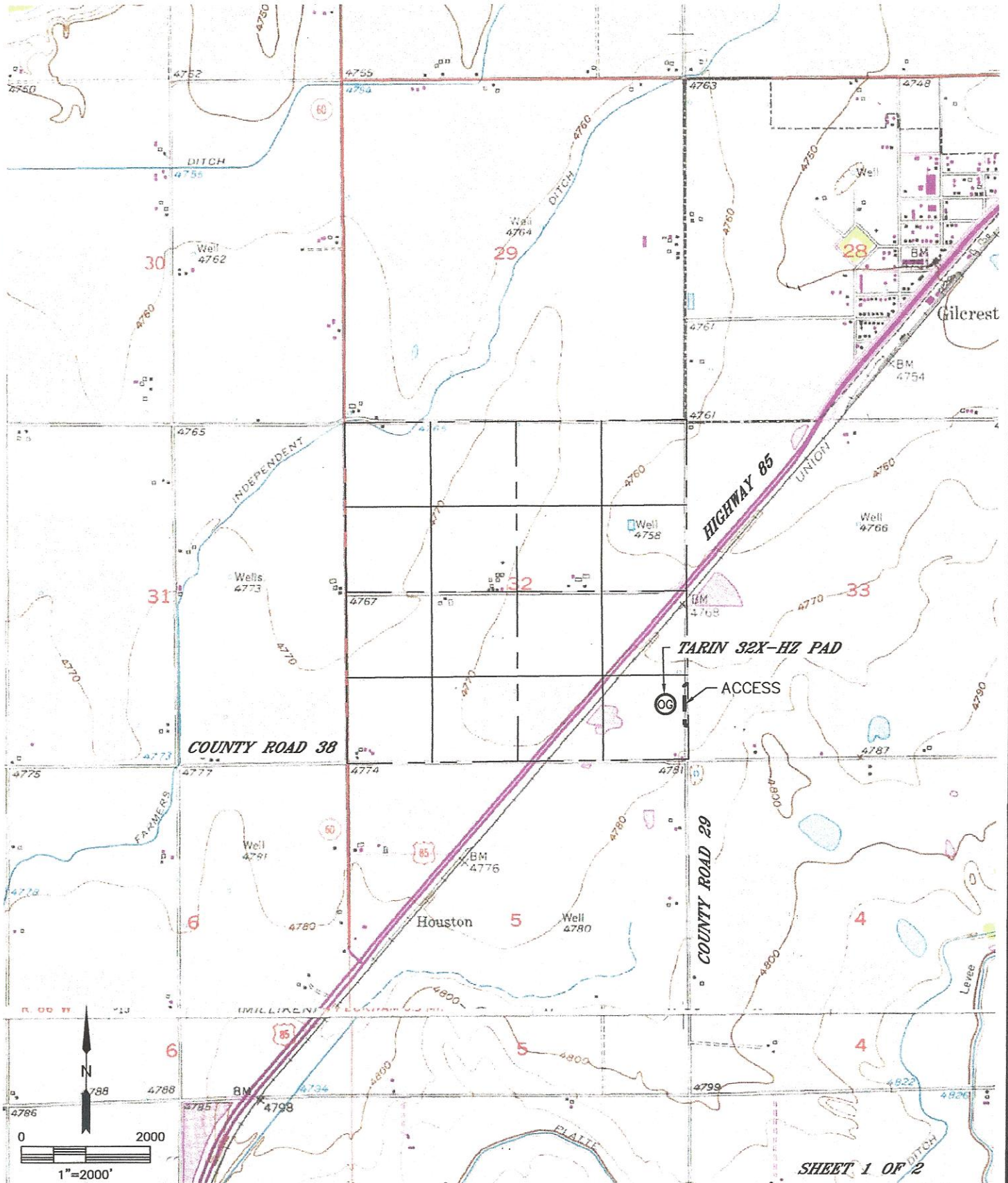

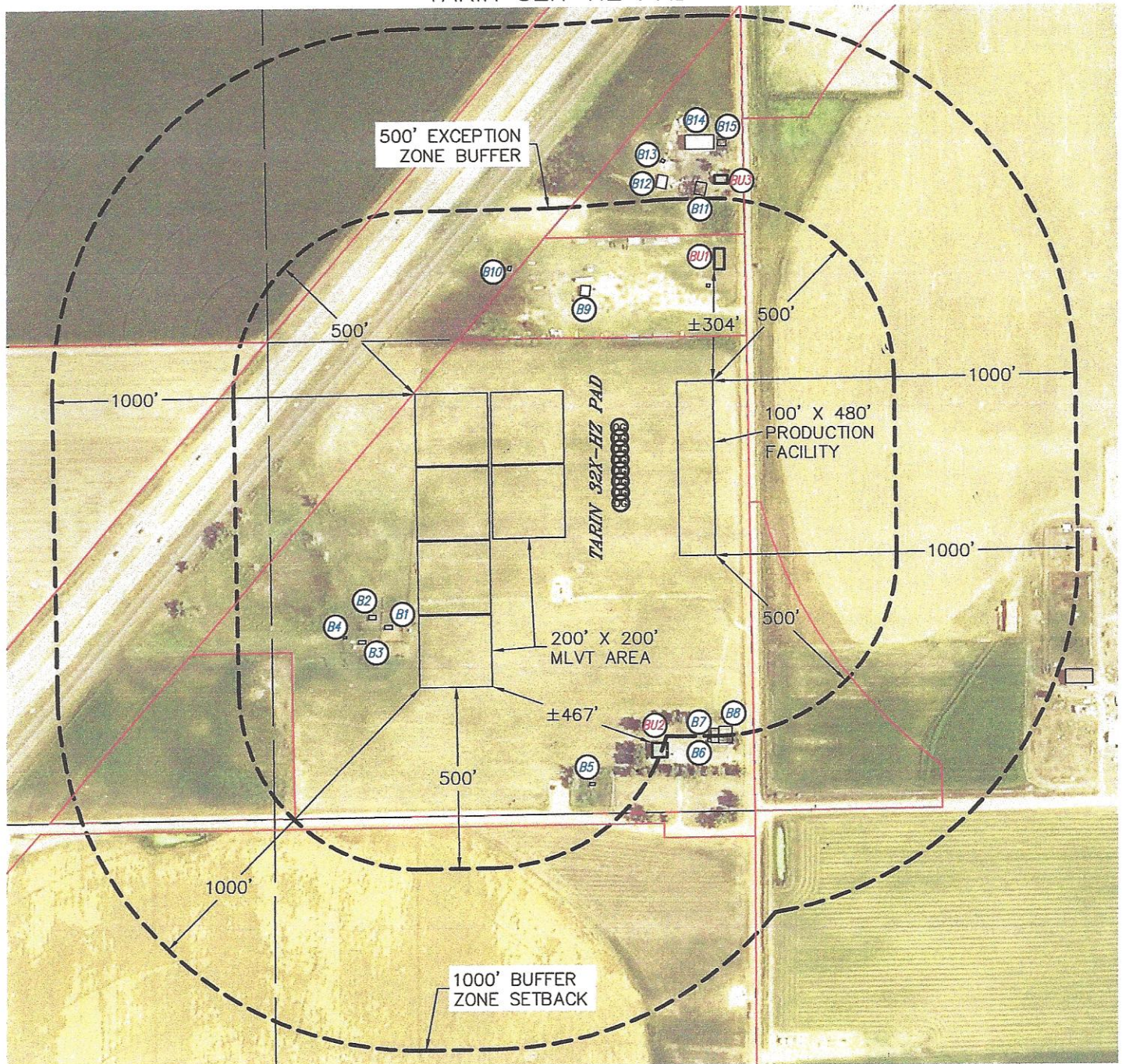

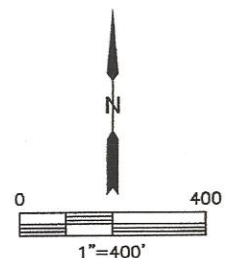
