COMMENTS:

Attached with this COGCC Form 4 is the sampling summary for the groundwater samples collected in the second quarter of 2014 along with the summary of the passive bioremediation system. The COGCC remediation number for this project is 5258. The 2014 second quarter sampling event was completed on May 29, 2014. Results are summarized in the attached Table 1. MW 2, MW3, MW4, and MW8 continue to exceed the COGCC cleanup concentrations for benzene of 5 ug/L. Therefore WPX installed Barometrically Assisted Remediation Technology (BART) valves which are utilized for passive in-situ vapor extraction of VOC's from the vadose zone soil above the hydrocarbon impacted groundwater. A total of 17 ports were installed. All of the ports were advanced to a total depth of 20-25 feet. 15 feet of screen was installed beginning at 10 bgs. The ports were completed with silica sand to an interval 1 foot above the top of the screened interval. A thick Bentonite seal was placed on top of the sand. The hole was then concreted to the surface. All of the ports protrude from the ground ~3ft above the surface and have been fitted with BERT™ passive ventilation ports (Baroballs). Attached is the Remediation Design Map with the BART valve locations. Monitoring well #2 has been fitted with a sipping pump to extract free product which was approximately 1.2 inches thick during the last sampling event. The pump configuration will draw the free product to the surface where it is stored in a 50 gallon drum with a pump shut-off mechanism once the barrel has been filled. The pump configuration has been inspected on a weekly basis since its installation and has been found to be working properly. Due to slow recharge rates on the free product, recovery is minimal. Inspection of the monitoring well on 07/23/14 revealed no free product in the well confirming the pump is functioning properly. WPX respectfully asks permission to change the sampling frequency from quarterly to semiannually (the second and fourth quarter of each year). The sampling schedule may be adjusted to a more frequent timeframe, depending on the sampling results.
