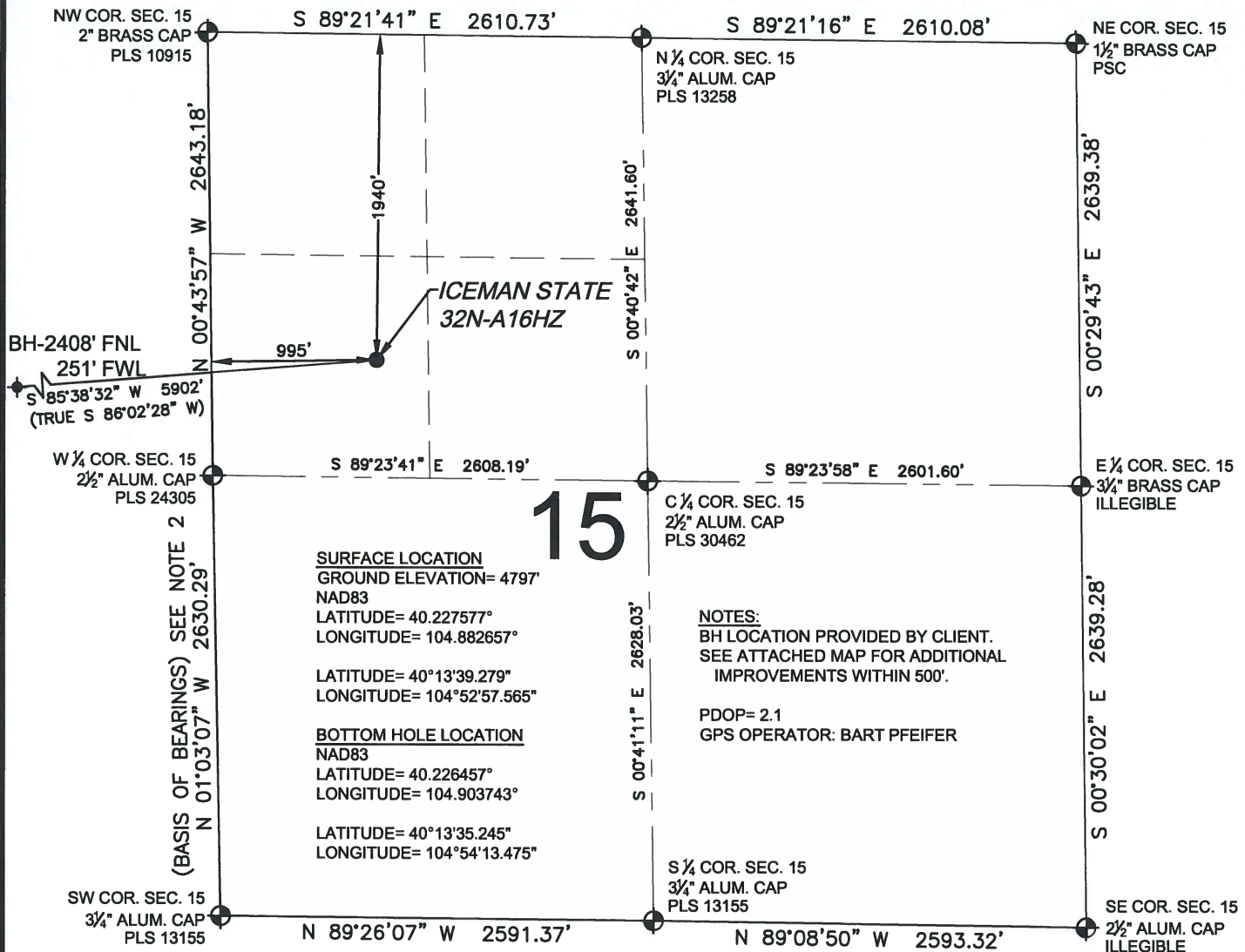


WELL LOCATION CERTIFICATE: ICEMAN STATE 32N-A16HZ

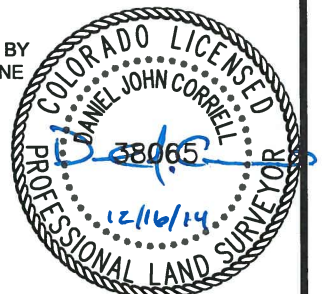
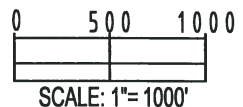

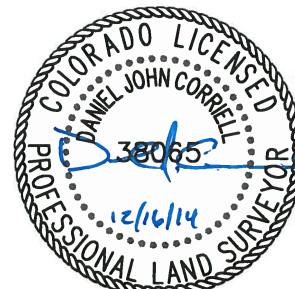
