KERR-MCGEE OIL & GAS ONSHORE LP (KERR-MCGEE) HAS CLOSED THE RESERVE PIT USED TO DRILL THE NYGREN 25-19 WELL. THE RESERVE PIT WAS LOCATED ON THE NYGREN 5-19 WELL PAD SITE. A BACKGROUND SOIL SAMPLE (RPBG01) WAS COLLECTED FROM THE BASE OF THE RESERVE PIT PRIOR TO THE PIT BEING UTILIZED FOR DRILLING ACTIVITIES OR INTRODUCING DRILLING MUD TO THE RESERVE PIT. RPBG01 WAS SUBMITTED FOR LABORATORY ANALYSIS OF TPH, BTEX, PH, EC AND TABLE 910-1 METALS. UPON COMPLETION OF THE DRILLING ACTIVITIES, THE DRILL MUD WAS REMOVED FROM THE RESERVE PIT AND EITHER RECYCLED OR LAND APPLIED. A CONFIRMATORY SOIL SAMPLE (RPBG02) WAS COLLECTED FROM THE BASE OF THE EMPTIED RESERVE PIT AND SUBMITTED FOR LABORATORY ANALYSIS OF THE ABOVE LISTED ANALYTES. LABORATORY RESULTS CONFIRM THAT ALL ANALYTE LEVELS WERE WITHIN COGCC ALLOWABLE LEVELS AND/OR BELOW THE BACKGROUND LEVELS DETECTED IN RPBG01. BASED ON THE LABORATORY RESULTS, KERR-MCGEE IS REQUESTING A NO FURTHER ACTION (NFA) STATUS FOR THE RESERVE PIT. LABORATORY REPORTS ARE INCLUDED AS AN ATTACHMENT TO THIS FORM 4.
