#### COMMENTS:

Pursuant to Rule 331 (Vacuum Pumps on Wells), BP America Production Company (BP) respectfully requests approval to impose a vacuum on the referenced Fruitland Coal well in order to access additional reserves.

The vacuum will be achieved by modifying the existing compressor already located on the wellsite. An oxygen analyzer will be installed for monitoring purposes in order to minimize the introduction of air to the system.

In support of this request, we have prepared an exhibit showing all wells located within ½ mile radius of the subject well. No non-BP operated wells were identified producing from the Fruitland Coal within ½ mile radius of our proposed well.
