This Outcome Letter is to inform you of the status of the violation(s) alleged in the above referenced Warning Letter.

Rules 905 and 909:

Required Corrective Action: The Bingman 1-14 Pit is an earthen and unlined production pit that was originally permitted on April 28, 2006 by Dry Creek Petroleum, LLC (Doc. No. 010433383), from which Diversified acquired the Bingman Location and associated facilities on July 11, 2012 (Doc. No. 2172784). The JP Weise 1 Pit is an earthen and unlined production pit that was originally permitted on April 28, 2006 by Dry Creek Petroleum, LLC (Doc. No. 010433383), from which Diversified Energy, LLC (Diversified) acquired the Bingman Location and associated facilities on July 11, 2012 (Doc. No. 2172784).



Pursuant to Rules 905 and 909, Diversified is required to properly close the Bingman and JP Weise Pits and to remediate the sites and remaining soils to comply with the 900 and 1000 Series Rules, including Table 910-1 standards.

Corrective Action Deadline Dates: See Appendix A to Warning Letter #2193287

Corrective Action Status: Diversified and COGCC Staff reached agreement on a modified Compliance Schedule on March 31, 2016 (Document #2193300). Document #2193300 shall dictate the Corrective Action requirements and schedule for these issues moving forward.

Outcome of Warning Letter #2193287: The required Corrective Actions remain outstanding and shall be completed pursuant to the modified Compliance Schedule in Document #2193300.
