Corrective Action: Remove the degraded hay bale debris from the location. Decompact soils by cross ripping to a depth of 18inches. Reseed the access road and location and stabilize disturbed soils to prevent erosion using a weed free mulch or equivalent method.

Operator Comment: Wiepking-Fullerton is submitting this Field Inspection Report Resolution (FIRR) form in response to the Corrective Actions identified in the COGCC inspection conducted on October 11, 2016 (COGCC Doc No. 673503798).

On October 30, 2016, Wiepking-Fullerton performed subsequent reclamation activities. The additional

reclamation activities included removal of debris, soil compaction alleviation by cross ripping the site to a depth of 18 inches below ground surface, applied Simplot 40-Rock fertilizer at a rate of 50 pounds per acre, seeded the location with NRCS recommended seed mix specific to the location (attached), and crimped in straw at a rate of 2,000 pounds per acre for erosion prevention.

Photos of the reclamation activities were taken on November 14, 2016 (attached).

Wiepking-Fullerton will continue to monitor the site until final reclamation objectives per COGCC Rule 1004 is achieved. Additionally, Wiepking-Fullerton will be submitting a variance request per COGCC Rule 1001.c. in response to the landowners request to keep the access road for on-going ranching operations.
