Comment: All equipment, gravel, and debris have been removed. There are areas at the location where soils appear to be compacted. Soil decompaction must be performed by cross ripping to a minimum depth of 18 inches. Was unable to determine if seeding has been performed. Additional decompaction and seeding should be performed prior to the growing season. It is recommended that a certified weed free mulch be applied to stabilize the soils and facilitate vegetation establishment. See Attached Photos
