Comment: Originally submitted as F-4 on 1/4/2013 but never processed by COGCC. Re-submitted Sept 2017. This was a blowdown pit with no permit required but was permitted by previous operator as # 117048 with no other information in Scout Card. Pit was over-excavated in 2012 with offsite disposal of contaminated soil. Confirmation samples were Table 910-1 compliant. Pit remains open ~10X20ft by 6-8 ft deep. Some weed growth in pit. No indications of petroleum contamination such as staining or odor. Possible flow line riser near pit.

Corrective Action: Backfill pit with clean fill and reclaim surface in accordance with the COGCC 1000 Series Reclamation Rules plus all surface owner (BLM) requirements. If riser is a Bayless flowline, ensure that line has been properly abandoned in accordance with COGCC rules and notice to operators.
