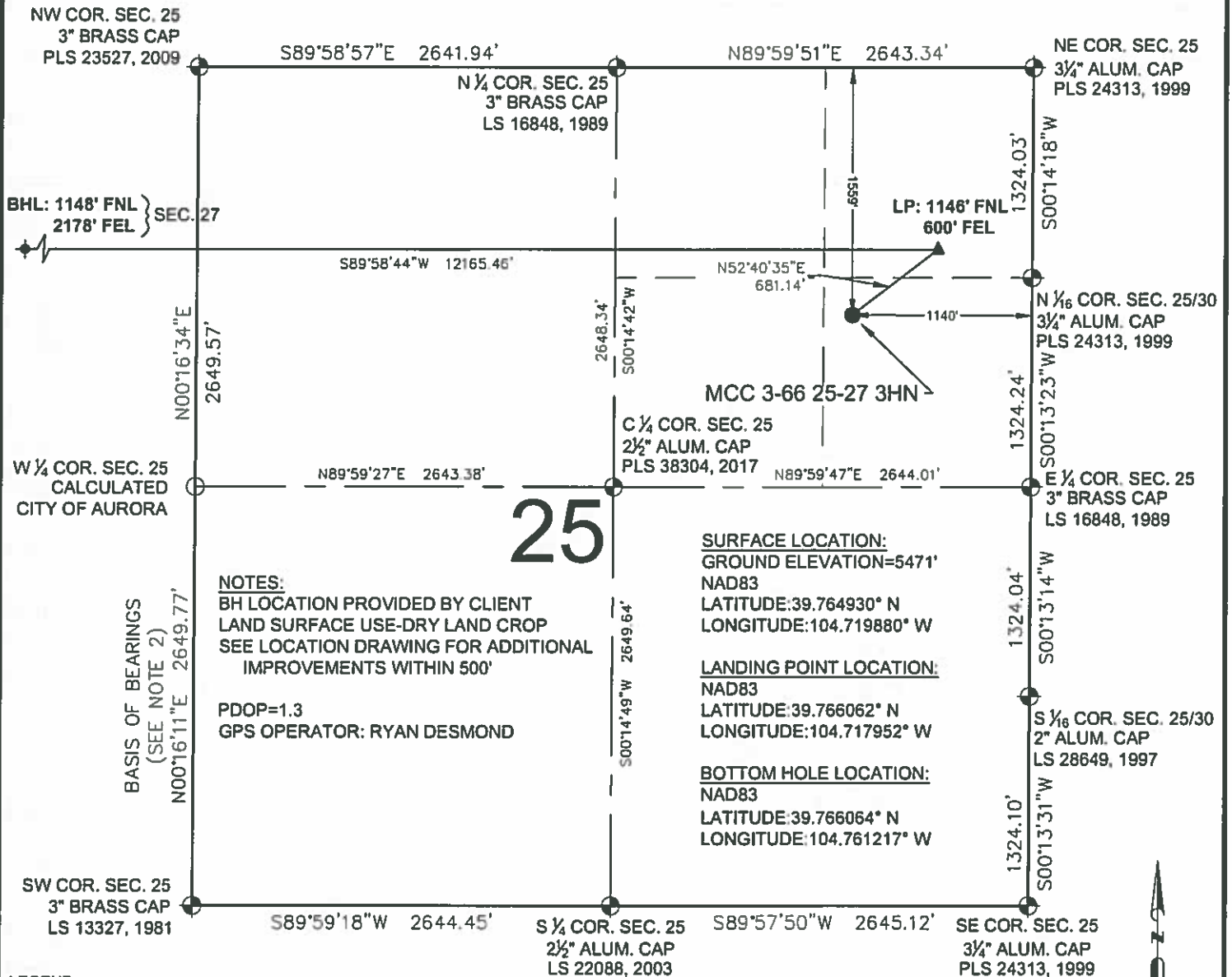


MCC 3-66 25-27 3HN WELL LOCATION CERTIFICATE
