<p>On January 5, 2018 COGCC SW EPS Jim Hughes conducted an environmental field inspection of the Petrox Resources Inc. Lark 33-5 #21-4. This field inspection resulted from a complaint regarding a release on the location. Imaged submitted to the COGCC showed a horizontal tank attached to the well head with fluids around it and mist coming from the top of the tank. For the most recent field inspection report of this facility, please refer to document #674901232.</p> <p>The horizontal tank had been removed, reportedly earlier on 1/5/18, by the time of this field inspection. A mark from the skid was present where the tank sat. Damp soil was present surrounding the area where the tank was located. Dusty Nystrom, Petrox representative, collected a soil sample of the impacted area. 5 - 4 oz. glass sample jars and two Ziploc bags were filled with the damp soil from 37.08489/-107.40588 for analysis at Green Analytical Laboratory.</p> <p>The contact information on the well signs was temporarily corrected with a marker, when the operator was told that the listed number had been disconnected.</p> <p>During this inspection a leaking hammer union in the separator shack for the #21-4 was observed. The operator was notified and the connection was tightened up, stopping the release.</p>	hughesj	01/05/2018
