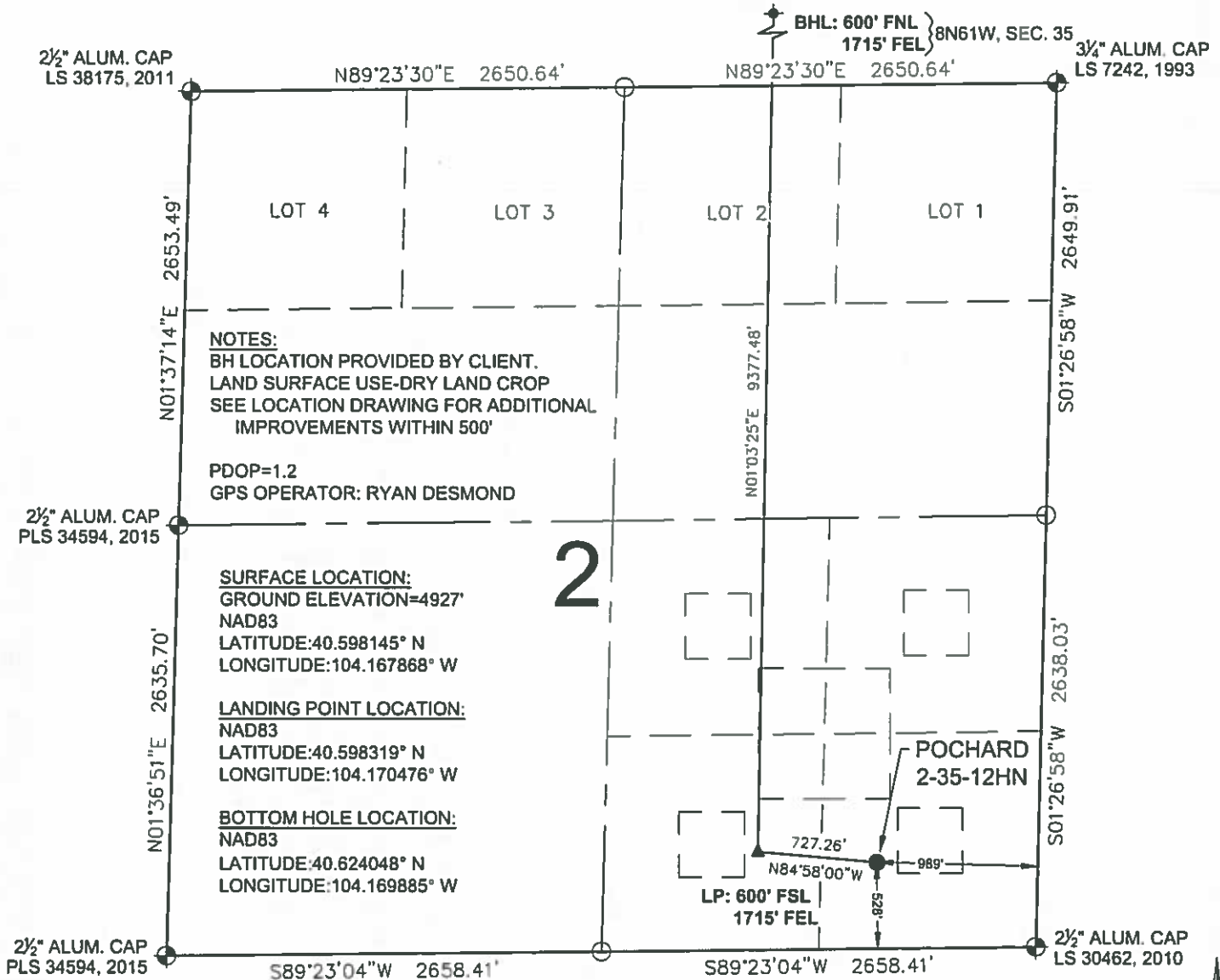


POCHARD 2-35-12HN WELL LOCATION EXHIBIT



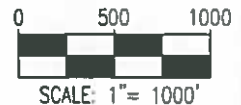

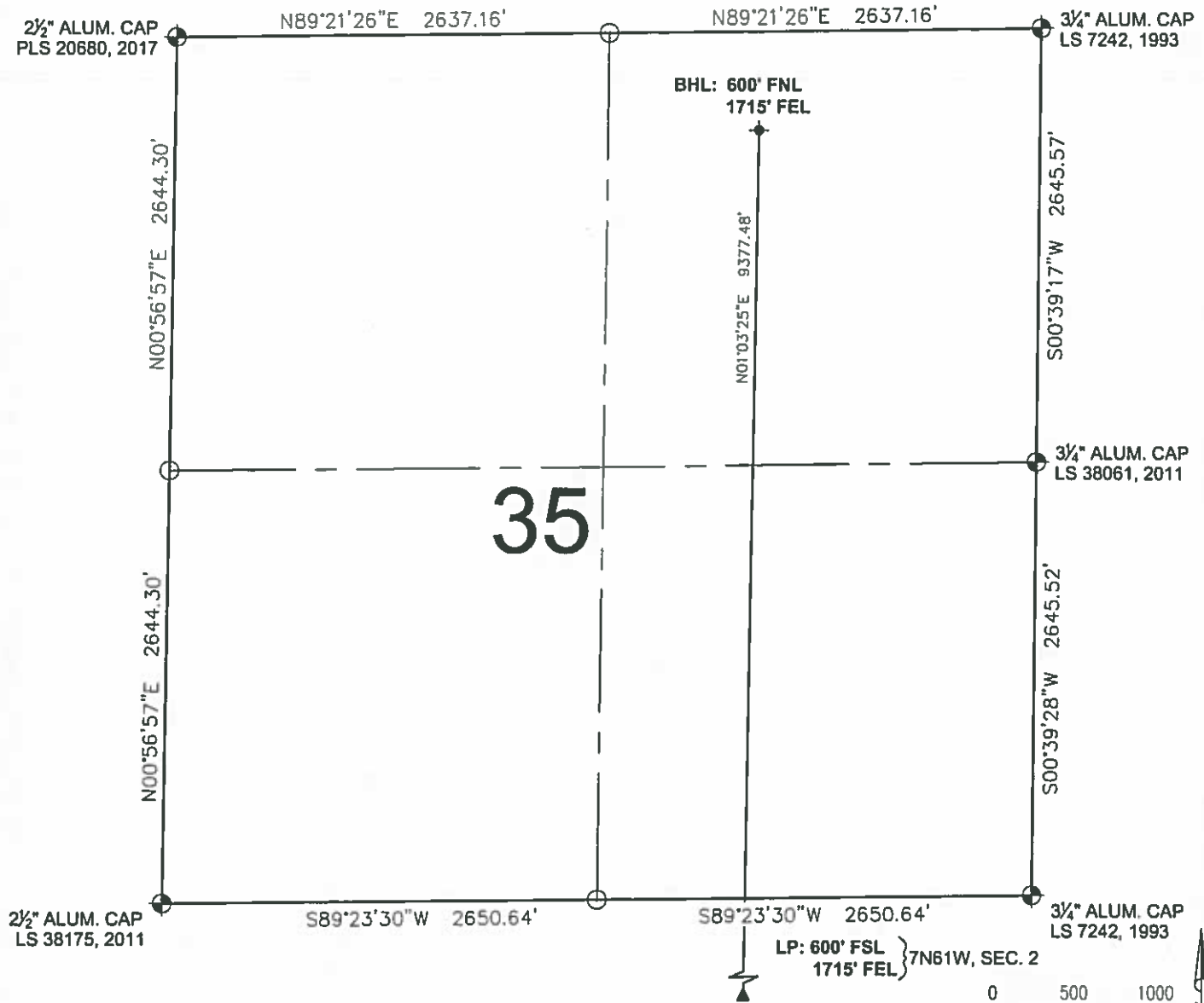
