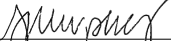

1	Planning	The first well drilled on the NPR H15 Pad will be logged with an open-hole Resistivity Log and Gamma Ray Log from TD into the surface casing. All wells on the pad will have a Cement Bond Log with cased-hole Gamma Ray run on the production casing. The Form 5 Completion Report will list all the logs run in the subject well and identify the well that was logged with the open-hole Resistivity Log.
2	Drilling/Completion Operations	Closed loop system will be used. No pits will be built. Caerus will ensure 110 percent secondary containment for any potential volume of fluids that may be released.

Engineer	Offset water well check: COGCC evaluated offset water wells within one mile of this proposed well's surface hole location. All permitted water wells within the search radius show zero for reported depths. Depths to formation tops in offset oil and gas wells, locally-available geophysical logs, and hydrogeologic information was used to evaluate the adequacy of the operator's proposed surface casing setting depth.  Offset Well Evaluation: Existing offset oil and gas wells within 1,500 feet of the wellbores on this pad meet standards. No mitigation required. N.PARACHUTE WF09D #M14 596 API #045-13367 (~720' from one planned well on the pad) was completed in the Wasatch and permitted to inject into the Williams Fork and Wasatch (doc# 2082609) in 2008 but injection was not performed. In 2009 a sundry was approved to return the well to production (doc #1905723). Emailed operator regarding Wasatch coverage. Operator provided geologic information that shows the Wasatch G zone is shale with a discontinuous sandstone that may be charged with hydrocarbons in the area. Referred issue to BLM (surface and mineral owner of the surface hole location). BLM requested Wasatch G coverage and operator agreed to increase the cement coverage. Removed operator's planned cement top. See condition of approval #3.	03/02/2018
