<p>On March 3, 2018 COGCC SW EPS Jim Hughes conducted an environmental field inspection of the Western Gas Resources WGR Hallmark #1-32. For the most recent field inspection report of this facility, please refer to document #680601920. Corrective actions noted in that inspection document have not been addressed. That document directed the operator to contact the SW EPS by 8/18/2017 regarding the NW corner of the location. On February 16, 2018 SW EPS Jim Hughes contacted the operator via telephone. The operator stated that the pit was excavated and then backfilled with the excavated material without ever being used, and that the well on the location was never drilled. Document #679893 in the COGIS database includes a field inspection from 6/2/1995 that states "pits were never built". The area in the northwest corner does not appear to have been impacted by E and P waste. The wind-rowed material was inspected during this site visit. The soil is light tan sandstone rubble while the surrounding soil is weathered red siltstone. The soil does not appear to be stained and does not have any detectable hydrocarbon odor. This field inspection, contact with the operator on February 16, 2018, and a thorough desktop review of documents associated with this location, including the 1995 pit inventory for Western Gas Resources which did not list a pit for the WGR Hallmark #1-32 location, indicate that there are no environmental concerns at the WGR Hallmark #1-32 well pad and location at this time.</p>	hughesj	03/05/2018
