Comments Distance to offset well permitted or completed in the same formation is 506 feet, the well is the CRITTER CREEK 14 SW 260-1411, this distance was measured in 2D.

Distance from proposed well to nearest well belonging to another operator is 667 feet, the well belongs to True Oil LLC and is the Ayars 13-14 (05-123-13076), this distance was measured in 3D.

This well has a bottom-hole location beyond the unit boundary setback. The bottom of the completed interval will be within the unit boundary setback at 330' FNL and 1342' FWL of Section 11. The wellbore beyond the unit boundary setback will be physically isolated and will not be completed.

All wells on the pad will have a cement bond log with gamma-ray run on production casing (or on intermediate casing if production liner is run) into the surface casing. The horizontal portion of every well will be logged with a measured-while-drilling gamma-ray log. The Form 5, Completion Report, for each well on the pad will list all logs run and have those logs attached. The Form 5 for a well without open-hole logs shall clearly state "No open-hole logs were run" and shall clearly identify (by API#, well name & number) the well in which open-hole logs were run.
