4-09-86	0 hours	Moved rig in. Dug deadmen.
4-10-86	0 hours	Unseated pump. Pulled rods. Pumped 150 bbls. water to wash oil out of tubing. Water truck, 3 hours.
4-11-86	0 hours	Rigged up tongs. Pulled tubing. Dug cellar.
4-14-86	0 hours	Rigged up jacks. Worked pipe to 12" tension. Ran sand from 6456' to 6250'. Loaded hole. Water truck, 3 hours.
4-15-86	0 hours	Ran tubing, 15 joints. Pulled out. Tried to run down other side. Pulled out. Put on spear. Ran 15 joints. Pumped 3 loads mud. Water truck, 6 hours. Dumped 5 sacks cement on sand.
4-16-86	0 hours	Pulled tubing. Shot holes at 1850'. Pumped one load water. Worked pipe. Pumped load of mud. Pumped 15 bbls. oil. Pushed plug to 90 bbls. water. Water truck, 5 hours.
4-21-86	0 hours	Worked pipe, still 12". Ran shot to 1000'. Pumped 3 loads mud. Worked pipe. No circulation. No pressure. Tried to run tubing, 15 joints. Water truck, 6 hours.
4-22-86	0 hours	Pulled tubing. Worked pipe at 8". Tore down jacks and rig. Moved.
5-05-86	0 hours	Moved on well. Rigged up jacks. Worked pipe to 12". Shot hole at 570'. Pumped 50 bbls. mud. Shot hole at 1000'. Pumped 50 bbls. mud. Worked pipe. Water truck, 3 hours. Vacuum Truck, 7 hours.
5-06-86	0 hours	Tried to run tubing. Ran 15 joints. Had to keep pumping out hole at 570'. Finally got in 35 joints. Water truck, 6 hours.

5-07-86	0 hours	Pumped in tubing. Circulated mud. Mixed 6 sacks mud. Pumped 5 loads mud and 23 bbls. oil. Water truck, 8 hours.
5-08-86	0 hours	Pulled tubing. Worked pipe at 11". Tried to fish plug at 1850'.
5-12-86	0 hours	Worked pipe to 40". Pused plug to bottom. Ran a shot to 5700'. Worked pipe from 40" to 53".
5-13-86	0 hours	Worked pipe. Ran a shot to 5400'. Worked pipe. Worked pipe loose. Pulled 92 joints.
5-14-86	0 hours	Pulled casing 134 total joints. Set 25 sacks cement in and out bottom of surface at 190'. Set 10 sacks in top. Welded on cap.
