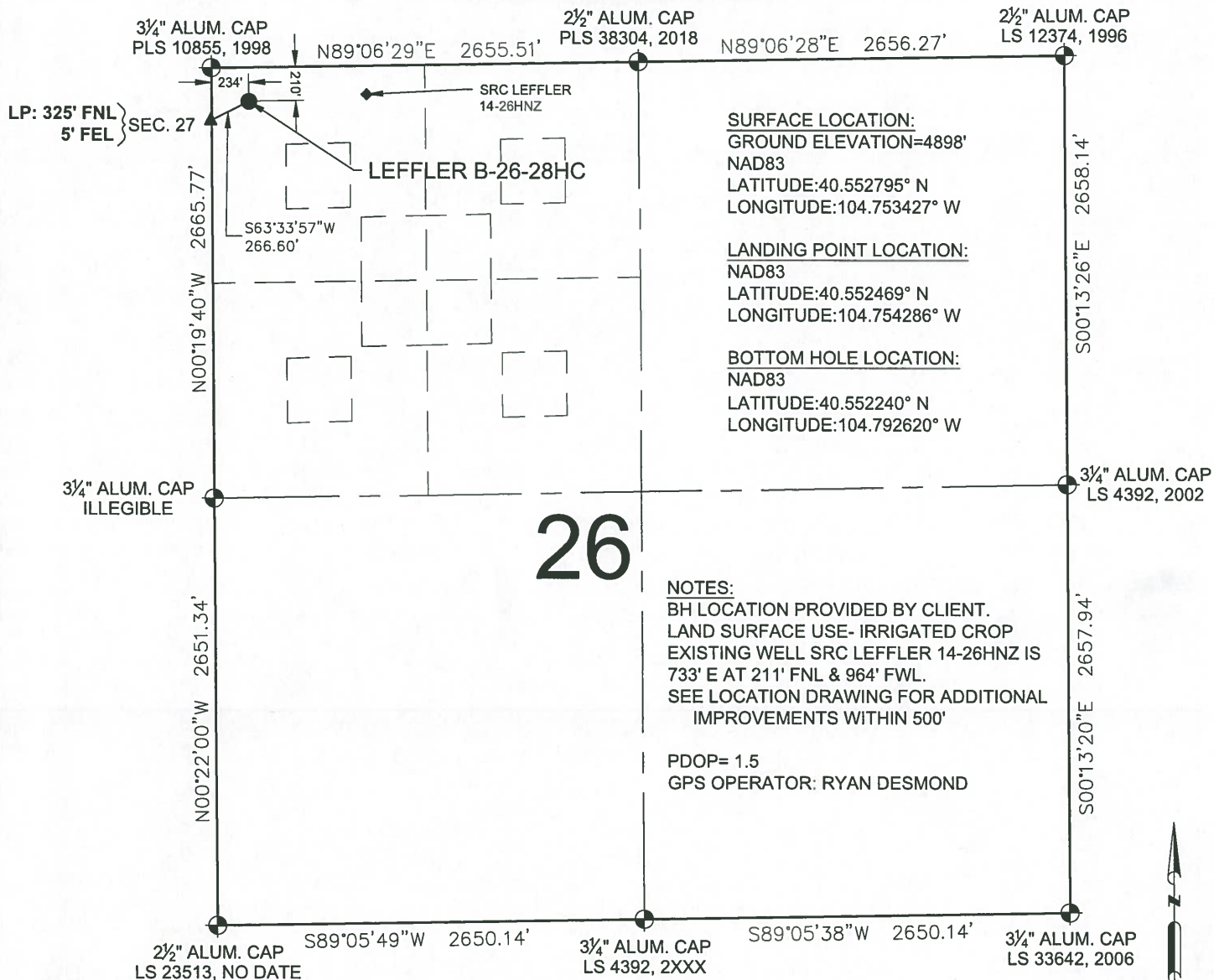


# LEFFLER B-26-28HC WELL LOCATION EXHIBIT
