N2N2 of Section 27 and 28, Township 7 North, Range 66 West
SWSW of Section 23, Township 7 North, Range 66 West
NWNW of Section 26, Township 7 North, Range 66 West

Containing 800.00 acres, more or less

Bayswater is not the only owner within the Proposed Spacing Unit and has provided notice to the remaining owners, as required by COGCC Rule 318A.e.(6). Copies of the required notification letters are on file at Bayswater's office. The required thirty (30) day notice period has elapsed absent the receipt by Bayswater of any objection to their proposal by the owners within the Proposed Spacing Unit for the subject wells.

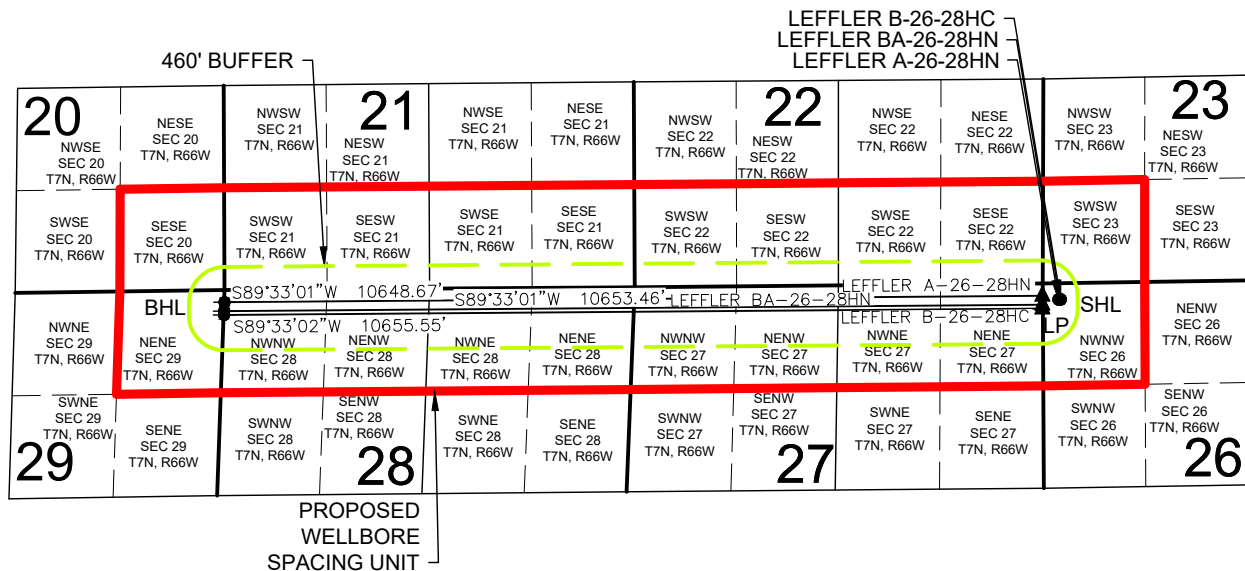
