Well File Verification	Contacted operator representative Neel Duncan. Overlap between bottom of 1st String and Top of Liner has been reduced from 52 ft to 21 ft. Mr. Duncan says this is inconsequential because the Liner Hanger is not sealing equipment. Injection is through the liner slots below the packer, where the hanger sits is not important. The shortened overlap is an effort to minimize the packer-top perforation distance and keep it under 100 ft. This minimized distance may become important if the packer has to be moved uphole in the future.	03/15/2019
