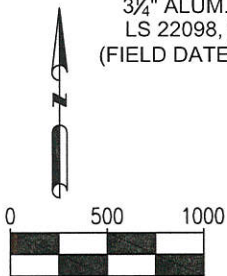
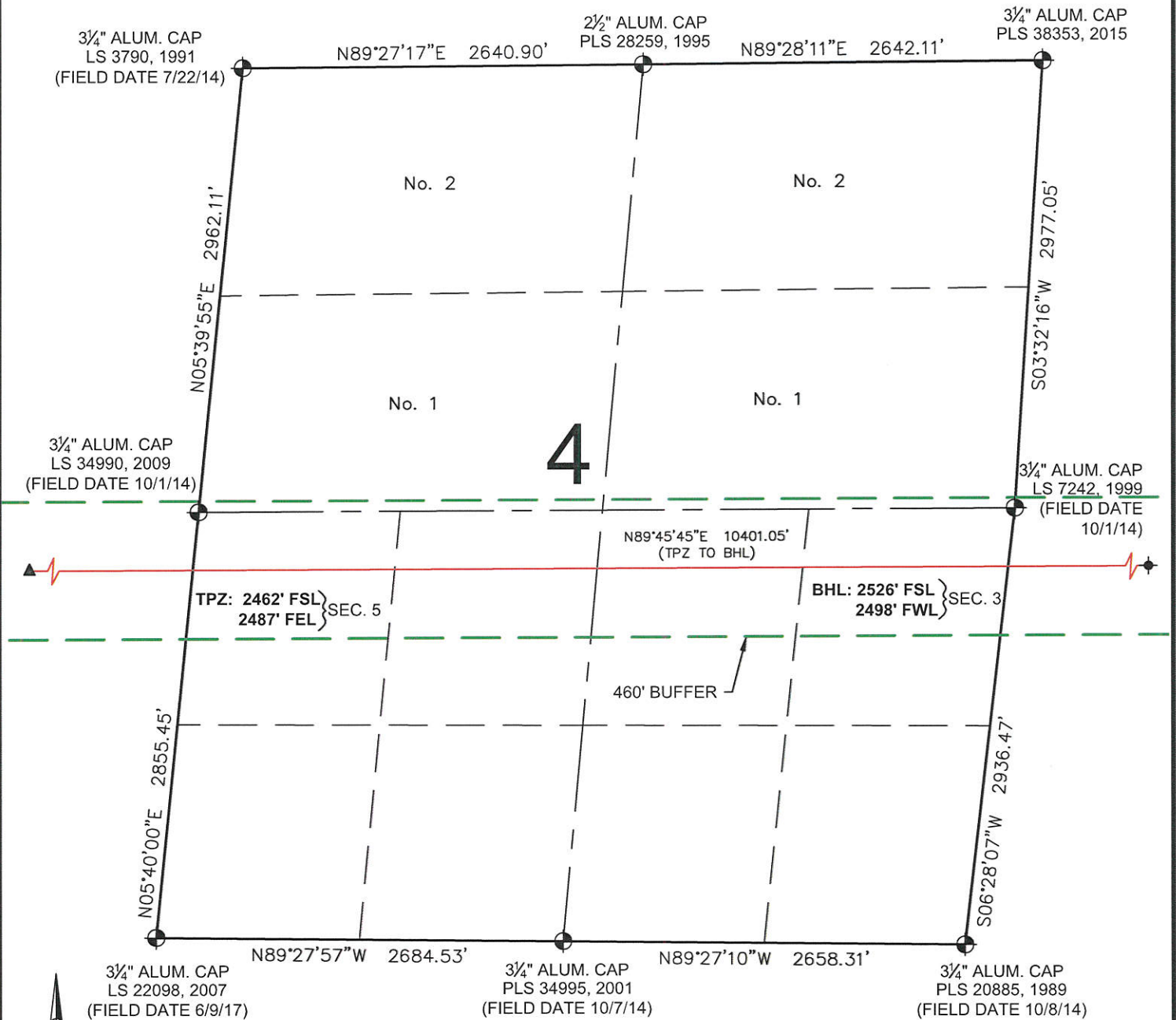

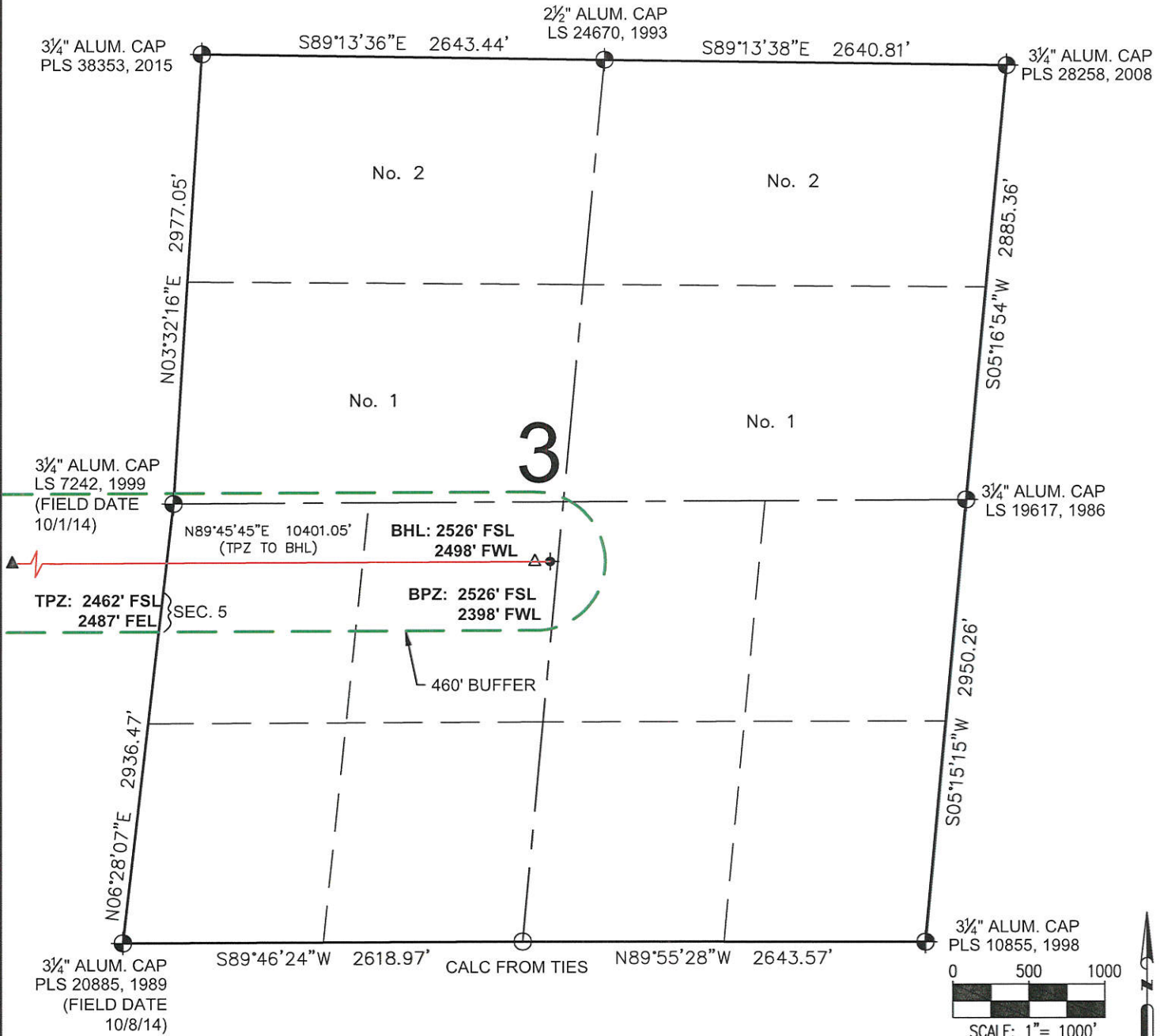

VOLT 25C-3-L WELL LOCATION EXHIBIT

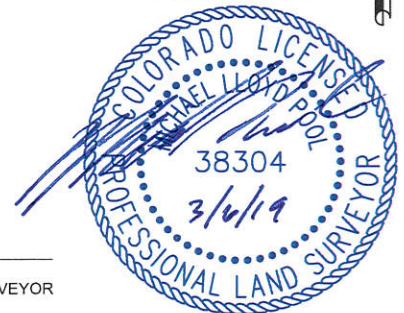
