

(5). Copies of the required notification letters are on file at SRC Energy's office. The required thirty (30) day notice period has elapsed absent the receipt by SRC Energy of any objection to their proposal by the owner(s) within the proposed spacing unit for the subject well. VOLT 34N-6C-M WELLBORE SPACING UNIT




VOLT 34N-6C-M WELL TO BE LOCATED 1167' FSL AND 2022' FWL, SEC 5, T5N, R66W
