OPERATOR COMMENT AND SUBMITTAL

Comment: Laramie has made every effort to encourage the landowner to remove the equipment noted in the inspection. In reviewing the above referenced COGCC Inspection for location ID 312445, a corrective action was identified for having the property owner move his vehicle and equipment off Location per rule 603.f. In reviewing Laramie Energy's Surface Use and Access Agreement with the landowner, Laramie does not have the authority to direct the landowner to remove his equipment and vehicles from his property. Laramie does maintain the oil and gas operations area free of any oilfield related equipment as per rule 603.f.

If the COGCC believes the landowner must comply with Rule 603.f., please feel free to contact him directly and inform him of the COGCC's requirements. Again, other than operating within the bounds of the Surface Use and Access Agreement for Oil and Gas Operations, Laramie does not believe it has the legal authority to infringe upon a private surface owners property rights and direct them on what they can do on their property. That being said, if there is a Colorado State Statute that gives the Operator the authority to infringe upon the landowners property rights, please direct us to the statute so Laramie may review it.
